Official Rules

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. THE PROMOTION (DEFINED BELOW) IS INTENDED FOR THE UNITED STATES ONLY AND WILL BE GOVERNED BY U.S. LAW. DO NOT ENTER IF YOU ARE NOT ELIGIBLE AND LOCATED IN THE UNITED STATES AT THE TIME OF ENTRY. VOID IN FLORIDA, NEW YORK, PUERTO RICO AND WHERE PROHIBITED. IN THE EVENT THE SWEEPSTAKES IS ENTERED VIA A MOBILE DEVICE, MESSAGE AND DATA CHARGES MAY APPLY.

- 1. SPONSOR.** Kansas City Chiefs Football Club, Inc., a Texas corporation, located at The University of Kansas Heath System Training Complex, One Arrowhead Drive, Kansas City, Missouri 64129 (“**Sponsor**”). This Promotion is in no way sponsored by, endorsed by, administered by, or associated with any third-party social media site, including but not limited to YouTube, Instagram, X f/k/a Twitter, or TikTok.
- 2. ELIGIBILITY.** The QVChiefs Hotline Sweepstakes (the “**Promotion**”) is open to residents of the United States, except where void, who are eighteen (18) years of age or older at time of entry. The Promotion is void in Florida, New York, Puerto Rico, outside the United States and where prohibited by law. Employees of Sponsor and its parent companies, affiliates, subsidiaries, sales representatives, advertising, sales promotion, and judging agencies, and all other service agencies involved with the development, production, implementation, administration, or fulfillment of the Promotion, and members of the immediate families (defined for these Official Rules as spouses, parents, children, siblings, and each of their respective spouses, regardless of where they reside) or individuals living in the same household (whether related or not) of any of the above are not eligible to participate.
- 3. PROMOTION PERIOD.** The Promotion begins on Thursday, May 14, 2026, at 7:00 P.M. Central Time (“**CT**”) and ends on Wednesday, May 20, 2026, at 11:59 P.M. CT (the “**Promotion Period**”). Sponsor’s clock is the official timekeeping device for the Promotion.
- 4. HOW TO ENTER.** During the Promotion Period, eligible entrants may enter this Promotion by calling the phone number (1-888-343-6642) featured in the QVChiefs Schedule Release video, located on the Sponsor’s Instagram account, Tiktok account, X f/k/a account, and/or YouTube page (<https://www.youtube.com/channel/UC-hXefb6XBFSubWz6Ezf 1A>) and leaving a voice mail with your first and last name, phone number and email address (each, an “**Entry**”). Entrants must complete all required steps and/or provide all requested information in the Entry to be eligible to win. No purchase is necessary to enter or claim the Prize, and a purchase will not increase your chances of winning. **Limit: one (1) Entry per person/phone number.** Entries received from any person/phone number in excess of the stated limitation will be void. Sponsor reserves the right to randomly select another Winner. The random drawing on the Draw Date will be conducted by Sponsor, whose decisions are final and binding on these Official Rules, conduct, results and all other matters relating to the Promotion. Sponsor shall not enter into any correspondence or discussion of the foregoing.
6. **WINNER NOTIFICATION.** If you are selected as a potential Prize winner (a "**Winner**"), you will be notified on or around the Draw Date by email or phone number (each potential Winner will be notified via the email or phone number provided in the winning Entry) and you will be required to respond to the notification within forty-eight (48) hours indicating whether you can accept the Prize. If no response is received within the time allotted, an alternate Winner will be randomly selected (time permitting). The alternate Winner selected will also be required to respond to the notification within forty-eight (48) hours.
