

Kansas City Chiefs® 2023 Renewal Sweepstakes

Official Rules

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. THE PROMOTION (DEFINED BELOW) IS INTENDED FOR THE UNITED STATES ONLY AND WILL BE GOVERNED BY U.S. LAW. DO NOT ENTER IF YOU ARE NOT ELIGIBLE AND LOCATED IN THE UNITED STATES AT THE TIME OF ENTRY. VOID IN FLORIDA, NEW YORK, PUERTO RICO AND WHERE PROHIBITED. IN THE EVENT THE SWEEPSTAKES IS ENTERED VIA A MOBILE DEVICE, MESSAGE AND DATA CHARGES MAY APPLY.

- 1. SPONSOR.** Kansas City Chiefs Football Club, Inc., a Texas corporation, located at The University of Kansas Health System Training Complex, One Arrowhead Drive, Kansas City, Missouri 64129 (“**Sponsor**”).
- 2. ELIGIBILITY.** The Kansas City Chiefs® 2023 Renewal Sweepstakes (the “**Promotion**”) is open to residents of the United States, except where void, who are eighteen (18) years of age or older at time of entry. The Promotion is void in Florida, New York, Puerto Rico, outside the United States and where prohibited by law. Employees of Sponsor and its parent companies, affiliates, subsidiaries, sales representatives, advertising, sales promotion, and judging agencies, and all other service agencies involved with the development, production, implementation, administration, or fulfillment of the Promotion, and members of the immediate families (defined for these Official Rules as spouses, parents, children, siblings, and each of their respective spouses, regardless of where they reside) or individuals living in the same household (whether related or not) of any of the above are not eligible to participate.
- 3. PROMOTION PERIOD.** The Promotion begins on Wednesday, February 8, 2023 at 12:01 AM CST and ends Friday, February 24, 2023 at 11:59 PM CST (the “**Promotion Period**”). Sponsor’s clock is the official timekeeping device for the Promotion.
- 4. HOW TO ENTER.** Kansas City Chiefs season ticket members (“**Members**”) who renew their season tickets for the 2023 season will be automatically entered into the Promotion but may opt out at any time. During the Promotion Period, you may enter this Promotion without purchasing a product or service by sending an email to fanexperience@chiefs.com that demonstrates your intent to participate in the Promotion. Members may be solicited by Sponsor using the contact information previously provided to Sponsor to confirm whether such Members wish to participate in the Promotion. Members may opt out of such communications by following the instructions described in such communications for unsubscribing. No purchase is necessary to enter or claim the Prize, and a purchase will not increase your chances of winning. **Limit: one (1) entry per person/household/email address.** Entries received from any person/household/email address in excess of the stated limitation will be void. All entries must be received with all required elements no later than the conclusion of the Promotion Period.

Use of multiple email addresses, phone numbers and/or mailing addresses, identities, registrations and logins, or any other methods and/or the manipulation of such information, for the purpose of obtaining more than the stated number of entries, is prohibited and such persons will be disqualified and all entries will be deemed invalid and any Prize won shall be forfeited. Sponsor will not verify receipt of entries. Multiple entrants are not permitted to share the same email address.

- 5. DRAW DATE.** On or around twenty-one (21) potential Winners will be randomly selected on or before the end of the Promotion Period (the “**Draw Date**”) from among all eligible entries received during the Promotion Period prior to the time of drawing. Sponsor reserves the right to randomly select another Winner. The random drawings on the Draw Date will be conducted by Sponsor, whose decisions are final and binding on these Official Rules, conduct, results and all other matters relating to the Promotion. Sponsor shall not enter into any correspondence or discussion of the foregoing.

6. **WINNER NOTIFICATION.** If you are selected as a potential Prize winner (a “**Winner**”), you will be notified within seventy-two (72) hours of the conclusion of the Promotion Period. Sponsor will notify you by in-person communication, phone, and/or email and you will be required to respond to the notification within forty-eight (48) hours indicating whether you can accept the Prize. If no response is received within the time allotted, an alternate Winner will be randomly selected (time permitting). Any alternate Winner selected will also be required to respond to the notification within forty-eight (48) hours.

Sponsor is not responsible for suspended or discontinued Internet, wireless, or land-line phone service which may result in a Winner not receiving initial Prize notification. Sponsor is not responsible for any entrant’s change of email address, mailing address, telephone number, and/or other contact information.

No consolation prizes will be awarded. Odds of winning depend upon the number of eligible entries received. Sponsor reserves the right to substitute the Prize for a prize of equal or greater value at any time.

Further, Sponsor reserves the right, at its sole discretion, to cancel, terminate, modify or suspend the Promotion or these Official Rules without notice.
