



Kansas City Chiefs® and Sony® Headphones Sweepstakes

Official Rules

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. THE PROMOTION (DEFINED BELOW) IS INTENDED FOR THE UNITED STATES ONLY AND WILL BE GOVERNED BY U.S. LAW. DO NOT ENTER IF YOU ARE NOT ELIGIBLE AND LOCATED IN THE UNITED STATES AT THE TIME OF ENTRY. VOID IN FLORIDA, NEW YORK, PUERTO RICO AND WHERE PROHIBITED. IN THE EVENT THE SWEEPSTAKES IS ENTERED VIA A MOBILE DEVICE, MESSAGE AND DATA CHARGES MAY APPLY.

- 1. SPONSOR.** Kansas City Chiefs Football Club, Inc., a Texas corporation, located at The University of Kansas Heath System Training Complex, One Arrowhead Drive, Kansas City, Missouri 64129 (“**Sponsor**”). Sony Electronics, Inc. is Sponsor’s partner for the Promotion (“**Partner**”).
- 2. ELIGIBILITY.** The Kansas City Chiefs® and Sony® Headphones Sweepstakes (the “**Promotion**”) is open to residents of the United States, except where void, who are eighteen (18) years of age or older at time of entry. The Promotion is void in Florida, New York, Puerto Rico, outside the United States and where prohibited by law. Employees of Sponsor and its parent companies, affiliates, subsidiaries, sales representatives, advertising, sales promotion, and judging agencies, and all other service agencies involved with the development, production, implementation, administration, or fulfillment of the Promotion, and members of the immediate families (defined for these Official Rules as spouses, parents, children, siblings, and each of their respective spouses, regardless of where they reside) or individuals living in the same household (whether related or not) of any of the above are not eligible to participate.
- 3. PROMOTION PERIOD.** The Promotion begins on Saturday, September 20, 2025, at 9:00 A.M. Central Time (“**CT**”) and ends Friday, December 26, 2025, at 11:59 P.M. CT (the “**Promotion Period**”). Sponsor’s clock is the official timekeeping device for the Promotion.
- 4. HOW TO ENTER.** During the Promotion Period, eligible entrants may enter by navigating to the “Gameday Challenge” page within Sponsor’s mobile application, clicking on the “Sony Sweepstakes Bonus Card” and completing the web form that the Bonus Card links to (also located at https://chiefs.formstack.com/forms/sony_sweepstakes) in its entirety, including providing your name and email address. You must complete all questions and submit requested information to enter the Promotion. Entrants must complete all required steps and/or provide all requested information in the web form or survey in order to be eligible to win. No purchase is necessary to enter or claim a Prize, and a purchase will not increase your chances of winning. **Limit: one (1) entry per person/email address.** Entries received from any person/email address in excess of the stated limitation will be void. All entries must be received with all required elements no later than the conclusion of the Promotion Period.

Use of multiple email addresses, phone numbers and/or mailing addresses, identities, registrations and logins, or any other methods and/or the manipulation of such information, for the purpose of obtaining more than the stated number of entries, is prohibited and such persons will be disqualified and all entries will be deemed invalid and any Prize won shall be forfeited. Sponsor will not verify receipt of entries. Entries that are late, lost, stolen, undelivered, illegible, damaged, misdirected, mutilated, garbled, incomplete, altered or otherwise irregular, generated by script, macro or other automated or mechanical means, or that contain false information, have been submitted through illicit means or by any means which subvert the entry process, or that do not conform with or satisfy any or all of the conditions set out in these Official Rules will be void. Multiple entrants are not permitted to share the same email address.
- 5. DRAW DATE.** One (1) potential Winner (defined below) will be randomly selected on or around Saturday, December 27, 2025 (“**Draw Date**”) from among all eligible entries received during the Promotion Period prior to the time of drawing. Sponsor reserves the right to randomly select an alternative Winner. The random drawing on the Draw Date will be conducted by Sponsor, whose decisions are final and binding on these Official Rules, conduct, results and all other matters relating to the Promotion. Sponsor shall not enter into any correspondence or discussion of the foregoing.

6. **WINNER NOTIFICATION.** If you are selected as the potential Prize winner (a “**Winner**”), you will be notified on or around the Draw Date by email (notice will be sent to the email address provided in your entry) and you will be required to respond to the notification within twenty-four (24) hours indicating whether you can accept a Prize. If no response is received within the time allotted, an alternate Winner will be randomly selected (time permitting). The alternate Winner selected will also be required to respond to the notification within twenty-four (24) hours. Sponsor is not responsible for suspended or discontinued Internet, wireless, or land-line phone service which may result in the Winner not receiving initial Prize notification.

If the Winner is eighteen (18) years of age, but considered a minor in state of residence, a Prize will be awarded to a parent/legal guardian of the Winner who must execute and return any required documents as noted in these Official Rules. Sponsor reserves the right to substitute the Prize for a prize of equal or greater value at any time.

Sponsor may share entries, including personal information contained therein, with Partner. Any personal data relating to entrants and subject to these Official Rules will not be disclosed to a third party without the individual’s prior consent. Personal data relating to entrants will be retained by Sponsor for a reasonable period after the Promotion closes to allow Sponsor to operate the Promotion and other promotional activities in a consistent manner and to deal with any queries on the Promotion, as well as to send information about Sponsor’s and Partner’s products to entrants. If you are selected as the Winner, your information may also be included in a publicly available winner’s list.

Any attempt to deliberately damage any website or undermine the legitimate operation of the Promotion is unlawful and subject to legal action by Sponsor or its agents. Further, Sponsor reserves the right, at its sole discretion, to cancel, terminate, modify or suspend the Promotion or these Official Rules without notice.
