

## Kansas City Chiefs® 2024 Bring the Energy Trivia Sweepstakes Official Rules

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. THE PROMOTION (DEFINED BELOW) IS INTENDED FOR THE UNITED STATES ONLY AND WILL BE GOVERNED BY U.S. LAW. DO NOT ENTER IF YOU ARE NOT ELIGIBLE AND LOCATED IN THE UNITED STATES AT THE TIME OF ENTRY. - 1. SPONSOR. Kansas City Chiefs Football Club, Inc., a Texas corporation, located at The University of Kansas Heath System Training Complex, One Arrowhead Drive, Kansas City, Missouri 64129 ("Sponsor"). Spire Inc. is Sponsor's marketing partner ("Marketing Partner") for this Promotion. By entering you agree that any questions related to the Promotion will be directed to Sponsor, and not to Marketing Partner.
- 2. ELIGIBILITY. The Kansas City Chiefs® 2024 Bring the Energy Trivia Sweepstakes (the "Promotion") is open to residents of the United States, except where void, who are eighteen (18) years of age or older at time of entry. The Promotion is void in Florida, New York, Puerto Rico, outside the United States and where prohibited by law. Employees of Sponsor or Marketing Partner and their parent companies, affiliates, subsidiaries, sales representatives, advertising, sales promotion, and judging agencies, and all other service agencies involved with the development, production, implementation, administration, or fulfillment of the Promotion, and members of the immediate families (defined for these Official Rules as spouses, parents, children, siblings, and each of their respective spouses, regardless of where they reside) or individuals living in the same household (whether related or not) of any of the above are not eligible to participate.
- **3. PROMOTION PERIOD.** The Promotion begins on November 18, 2024, at 12:01 A.M. CST and ends on December 15, 2024, at 11:59 P.M. CST (the "**Promotion Period**"). Sponsor's clock is the official timekeeping device for the Promotion.
- 4. HOW TO ENTER. During the Promotion Period, you may enter this Promotion by navigating to the following link: https://www.chiefs.com/fans/bringtheenergy, completing in entirety one (1) set of trivia questions available at the link referenced above, and by completing the contact information entry form at the end of a set of trivia questions. Throughout the Promotion Period, there will be two (2) sets of questions every other week, and you may receive one (1) entry for each fully-completed set of trivia questions. Entrants must complete all required steps and/or provide all requested information, which may include contact information, in order to be eligible to win. No purchase is necessary to enter or claim a Prize, and a purchase will not increase your chances of winning. Limit: four (4) entries per person. Entries received from any email address in excess of the stated limitation will be void. All entries must be received with all required elements no later than the conclusion of the Promotion Period.

Use of multiple email addresses, phone numbers and/or mailing addresses, identities, registrations and logins, or any other methods and/or the manipulation of such information, for the purpose of obtaining more than the stated number of entries, is prohibited and such persons will be disqualified and all entries will be deemed invalid and any Prize won shall be forfeited. Sponsor will not verify receipt of entries. In the event of a dispute regarding the identity of an entrant, such entry will be deemed to be made by the authorized account holder of the email address connected to an entry. "Authorized account holder" is deemed as the natural person who is assigned to an email address by an Internet access provider, service provider or other online organization that is responsible for assigning email addresses for the domain associated with the submitted email address.

- 5. DRAW DATES. Each week during the Promotion Period, Sponsor will randomly select one (1) potential Winner (defined below) from all eligible entries received for the prior week's trivia question set. One (1) potential Winner (defined below) will be randomly selected on or around December 13, 2024 for the Grand Prize (defined below) (the "Grand Prize Draw Date") from among all eligible entries received during the Promotion Period prior to the time of drawing. Sponsor reserves the right to randomly select another Winner at any time. All random drawings will be conducted by Sponsor, whose decisions are final and binding on these Official Rules, conduct, results and all other matters relating to the Promotion. Sponsor shall not enter into any correspondence or discussion of the foregoing.
- 6. WINNER NOTIFICATION. If you are selected as a potential Prize winner (a "Winner"), you will be notified on or around the applicable draw date. Sponsor will notify you by email (notice will be sent to the email address provided in your entry) and you will be required to respond to the notification within forty-eight (48) hours indicating whether you can accept the Prize. If no response is received within the time allotted, an alternate Winner will be randomly selected (time permitting). The alternate Winner selected will also be required to respond to the notification within forty-eight (48) hours. The Weekly Prizes will be awarded weekly as set forth in Section 5 above. At the end of the Promotion Period and in accordance with Section 5 above, Sponsor will award the final grand prize consisting of (a) four (4) single-game field passes for the Chiefs home game on December 21, 2024; (b) four (4) single-game club seats (all-inclusive of food and beverage) for the Chiefs home game on December 21, 2024; (c) post-game photo opportunity on the field for the Chiefs home game on December 21, 2024; and (d) one Chiefs helmet signed by Andy Reid (collectively, the "Grand Prize"). Approximate retail value of each Weekly Prize is \$100 USD. Approximate retail value of the Grand Prize is \$4000 USD. Approximate retail value of all Prizes is \$4400 USD. Any difference between stated value and actual value will not be awarded. A Prize is non-transferable and cannot be redeemed for cash. No consolation prizes will be awarded. Odds of winning depend upon the number of eligible entries received. Sponsor reserves the right to substitute a Prize for a prize of equal or greater value at any time.
