

2026 AVO COLTS SWEEPSTAKES
PRESENTED BY AVOCADOS FROM PERU

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN SWEEPSTAKES. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. THIS SWEEPSTAKES IS VOID WHERE PROHIBITED BY LAW.

1. Eligibility.

The 2026 Avo Colts Sweepstakes presented by Avocados from Peru ("Sweepstakes") is only open to persons who are legal residents of the State of Indiana who are 21 years of age or older as of the date of registration and hold a valid driver's license (each a "Participant" and collectively, "Participants"). Employees, officers, directors, agents, and representatives of the Indianapolis Colts, Inc. ("Club"), Peruvian Avocado Commission ("Sponsor"), the National Football League ("NFL"), or any of their respective agencies, owners, franchisees, subsidiaries, and affiliates, or the immediate family members (spouse, mother, father, sister, brother, daughter, son, grandson, or granddaughter, regardless of where they live), or members of their same households (whether related or not), or those individuals who have, in the previous six months, won any sweepstakes or prize sponsored by Club or Sponsor are not eligible to participate or win a prize. By entering, Participants agree to these Official Rules and the decisions of the Club, Sponsor, and the NFL (collectively, "Released Parties"), which shall be final and binding in all respects. The Sweepstakes is subject to all applicable federal, state, and local laws. Void where prohibited.

2. Sweepstakes Period.

The Sweepstakes begins at 12:01 a.m. Eastern Time on August 14, 2026, and ends at 11:59 p.m. Eastern Time on October 5, 2026 (the "Sweepstakes Period"). All entries become the sole and exclusive property of Club and Sponsor and will not be acknowledged or returned.

3. How to Enter.

Eligible Participants must follow the official Avocados from Peru and Meijer Instagram accounts, visit www.colts.com/avocolts, and follow the instructions provided to complete and submit an entry form with their contact information (each, an "Entry" and collectively, "Entries"). Participants can also enter by mailing their name, address, telephone number, and email address to Indianapolis Colts, Attn: "The 2026 Avo Colts Sweepstakes presented by Avocados from Peru" Entry, 7001 W. 56th Street, Indianapolis, IN 46254. Mailed entries must be postmarked by October 5, 2026. LIMIT ONE ENTRY PER HOUSEHOLD OR EMAIL ADDRESS DURING SWEEPSTAKES PERIOD (REGARDLESS OF WHETHER MORE THAN ONE PERSON USES THE SAME E-MAIL ADDRESS). If multiple Entries are received, only the first Entry will be entered into the Sweepstakes and all other Entries will be disregarded. In the event of a dispute as to any Entry, the authorized account holder of the e-mail address used to enter will be deemed to be the Participant. The "authorized account holder" is the natural person assigned an e-mail address by an Internet access provider, online service provider, or other organization responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. The potential winner may be required to show proof of being the authorized account holder, provided such individual is eligible according to these Official Rules.

4. Prizes and Selection of Winners.

The first prize winner shall win 2026 Toyota Tacoma ("First Place Prize"), the second prize winner shall receive \$2,000.00 in Meijer gift cards ("Second Place Prize"), and the third prize winner shall receive a VIP Colts Experience (which includes four tickets, one parking pass, and four pre-game sideline passes) to the Colts v. Bengals game in Week 16 of the 2026 NFL Season (date and time TBD) ("Third Place Prize") (collectively, "Prize"). Three winners will be selected in a random drawing by Club from all eligible Entries received during the Sweepstakes Period. The winners, and the Prize each winner will receive, will be announced during the Colts home game on October 18, 2026. Actual retail value (ARV) of the First Place Prize is approximately \$45,000.00. Actual retail value (ARV) of the Second Place Prize is approximately \$2,000.00. Actual retail value (ARV) of the Third Place Prize is approximately \$600.00. Actual value may differ at time of Prize award. The specifics of the Prize shall be solely determined by Sponsor. Odds of winning are dependent on the number of eligible Entries received during the Sweepstakes Period. Club will notify the winner individually by e-mail or phone. TRAVEL, MEALS, AND LODGING ARE NOT INCLUDED AS PART OF THE PRIZE.

The Prize Winners must respond within 24 hours of notification, or the Prize may be forfeited, and another potential Prize Winner chosen. Prize winners will be required to sign and return a liability release and a publicity release prior to the Prize being redeemed. In the event that a Prize Winner is disqualified for any reason, Club and Sponsor may select an alternate Prize Winner by random drawing from among all remaining eligible Entries.

First Place Prize winner may not sell Vehicle back to the dealership from which it is received. In the event Sponsor discovers that First Place Prize winner has sold the Vehicle to the dealership from which it is received, Sponsor reserves the right to request payment from First Place Prize winner for the total MSRP. Vehicle Delivery: First Place Prize winner is required to comply with all applicable federal, state, and local laws, rules, and regulations, including but not limited to licensing and insurance requirements. The MSRP of the First Place Prize is subject to price fluctuations in the consumer marketplace based on, among other things, any gap in time between the date the MSRP is estimated for purposes of these Official Rules and the date the prize is awarded or redeemed. Vehicle will be delivered with standard equipment for make and model; all upgrades and options, are at the sole cost of winner. Title, taxes, registration, license, and similar fees, and insurance costs are the sole responsibility of the winner. Winner must possess a valid U.S. driver's license. Winner will be required to show proof of currently valid driver's license and state mandated insurance prior to taking delivery of the vehicle. Sweepstakes Entities shall not be responsible for delays in availability of the Vehicle; final awarding of the Vehicle is subject to availability. Sweepstakes Entities shall use all reasonable efforts to award the Vehicle within 180 days after receipt of the First Place Prize Winner Documents. The First Place Prize Winner shall be solely responsible for all travel or transportation costs to and from the dealership. The First Place Prize Winner must personally retrieve the Vehicle within 30 days of written notification of delivery. The Vehicle will be delivered solely with the express written limited warranties set forth in the Vehicle's applicable Owner's Guide, which warranties shall run for the term set forth in said guide.

The Prize Winners and their guests, by acceptance of a Prize, except where legally prohibited, grant permission for Released Parties, and their respective designees, to use Prize Winners' and their guests' names, addresses (city and state), photographs, voices, likenesses, and Prize information for advertising, trade, and promotional purposes without further compensation, except as an endorsement of any commercial product or enterprise other than Club's, in all media now known or hereafter discovered, worldwide, in perpetuity, without notice or review or approval.

BY PROVIDING CONTACT INFORMATION, PARTICIPANT CONSENTS TO THE COLLECTION AND STORAGE OF THE INFORMATION PROVIDED. 7. Limitation of Liability and Dispute Resolution.

Except where prohibited, each Participant agrees that: (a) all issues and questions concerning these Official Rules shall be governed by the law of the State of Indiana without giving effect to any principles of conflicts of law of any jurisdiction; (b) any and all disputes, claims, and causes of action at law or in equity arising out of or relating to this Sweepstakes, or any prize awarded shall be: (i) resolved individually, without resort to any form of class action; and (ii) filed only in the courts of the State of Indiana, County of Marion, and Participant hereby consents and submits to the personal jurisdiction of such courts for the purposes of litigating any such disputes, claims or causes of action; (c) any and all claims, judgments, and awards shall be limited to actual out-of-pocket costs incurred, but in no event attorneys' fees; and (d) under no circumstances will any Participant be permitted to obtain awards for and hereby waives all rights to claim punitive, incidental, special, consequential damages, treble, or any other damages, other than for actual out-of-pocket expenses, or any and all rights to have damages multiplied or otherwise increased.
