2022 GetGo Fan Fuel Sweepstakes Promotion
Official Rules

NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED.

1. **Timing:** The 2022 GetGo Fan Fuel Sweepstakes Promotion (“Promotion”) begins on September 30, 2022, at 12:01 a.m. Eastern Time ("ET") and ends on October 31, 2022, at 11:59 p.m. ET (the “Promotion Period”). Sponsor's computer is the official time keeping device for this Promotion.
2. **Eligibility:** The Promotion is open only to legal residents of the State of Indiana (U.S.) who are at least 18 years old at the time of entry. Employees of Giant Eagle, Inc. (“Sponsor”), the Indianapolis Colts, Inc. (“Club”), and any of its affiliate companies, as well as the immediate family (spouse, parents, in-laws, siblings, and children) and household members of each such employee are not eligible. Void where prohibited by law. The Promotion is subject to all applicable federal, state, and local laws and regulations. Participation in the Promotion constitutes participant’s full and unconditional agreement to these Official Rules and by the Sponsor’s decisions, which are final and binding in all matters related to the Promotion. Winning a prize is contingent upon fulfilling all requirements set forth herein.
3. **How to Enter:** Eligible participants can register to win by completing the online entry form located at www.colts.com/GetGo (“Entry Process”). Registration is free. Limit one registration per Participant and per mobile number or email address.

Multiple submissions may result in disqualification. The use of scripts, macros, other automated means, or any other device to subvert the Entry Process is prohibited, and all such registrations will be void. In the event of a dispute as to the identity of a Participant based on the email address used at the time of registration, entry will be identified to the person named on the applicable registration form (regardless of whether that is the name of the authorized account holder of the email address from which said registration form was submitted), provided such individual is eligible according to these Official Rules. Club and Sponsor are not liable for any error, omission, interruption, defect, or delay in any transmission or communication; or for any technical problem, including but not limited to any injury or damage to Participant’s or any other person’s computer related to or resulting from participation in the Sweepstakes; typographical, printing, or other errors in these Official Rules, or in any Sweepstakes-related advertisements or other materials; the administration of the Sweepstakes, the processing of entries, the selection or announcement of winners, or the distribution of prizes; tabulation, timing errors, or other errors of any kind whether mechanical, human, electronic, typographical, or otherwise.

4. **Winner Selection and Notification:** On or after November 1, 2022, Club will randomly select one potential Grand Prize winner and ten potential Runner-Up Prize winners from among all eligible entries received during the Promotion Period. Drawings will take place at Club’s offices as set forth below. Winners need not be present. Potential winners will be notified by email or telephone on or after November 1, 2022. Except where prohibited, each potential winner may be required to sign and return to Club, within ten days of being notified, an Affidavit of Eligibility, Liability, and Publicity Release, in order to claim his/her prize. If a potential winner cannot be contacted within two days of the first attempt to contact him/her or if he/she fails to sign and return the Affidavit of Eligibility, Liability, and Publicity Release within the required time period or prize is returned as undeliverable, potential winner forfeits prize, and an alternate participant will be selected in his/her place at random from among all remaining eligible entries received during the Promotion Period. Only three alternate drawings will be held after which the prize will remain un-awarded. Prize will be fulfilled two weeks after winner confirmation.

Each participant agrees to irrevocably and unconditionally transfer and assign to Sponsor all rights to all information submitted during the Promotion, and agrees to execute and deliver such documents, certificates, assignments, and other writings, and take such other actions as may be necessary or desirable to vest in Sponsor the ownership rights granted to Sponsor hereunder.
7. **General Conditions:** Sponsor is not responsible for problems with the submissions, including, but not limited to, lost, late, incomplete, invalid, unintelligible, or misdirected entries, which will be disqualified. Sponsor reserves the right, in its sole discretion, to modify, suspend, or cancel the Promotion, or any part of it, if any fraud, technical failures, or any other factor beyond Sponsor’s reasonable control impairs the integrity or proper

functioning of the Promotion, as determined by the Sponsor in its sole discretion. In such event, Sponsor will select the winner(s) in a random drawing from the eligible entries received prior to the modification, suspension, or cancellation. Sponsor agrees to take such action in a fair and appropriate manner. In addition, Sponsor reserves the right, in its sole discretion, to disqualify any individual it finds to be tampering with the submission process or the operation of the Promotion or to be acting in violation of these Official Rules or any other promotion, or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately damage any other participant's submission or undermine the legitimate operation of the Promotion is a violation of criminal and civil law, and should such an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law.
