

Meijer 2018 Home Delivery by Blue Sweepstakes  
AMENDED OFFICIAL RULES

**NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.**

1. **HOW TO ENTER:** Meijer Great Lakes Limited Partnership (“Sponsor”) is pleased to present the Meijer 2018 Home Delivery by Blue Sweepstakes (the “**Sweepstakes**”), which begins at 12:01 a.m. EDT on 9/10/2018 and ends at 11:59 p.m. EST on 12/6/2018 (the “**Sweepstakes Period**”). Sponsor’s computer is the official time-keeping and counting device for the Sweepstakes. 4. **DRAWING:** Potential winners will be selected by random drawing by the Indianapolis Colts using the drawing dates shown in **Exhibit A** to select potential winners for each of the Prizes. The potential winners will be notified by Sponsor on or about the day of the drawing by supplied contact information and must respond within 48 hours from first notification. Limit one Prize per person and per household. Each potential winner will be required to sign and return a notarized Affidavit of Eligibility/Compliance (including, without limitation, providing his/her respective Social Security Number for tax purposes) and a Liability/Publicity Release, as allowed by state law, by the return date specified in the prize notification letter. The authorized account holder is defined as the natural person who is associated with the Meijer Home Delivery account and the natural person who is assigned to a phone number by a telephone service provider or other organization (e.g. (e.g., business, educational institution etc.) that is responsible for assigning phone numbers. Participants must enter using only the Meijer Home Delivery account registered in his/her name. The potential winner may be required to provide Sponsor with proof that he/she is the authorized account holder of the user name/ Meijer Home Delivery account associated with the winning entry.
