

2026 With This Diamond Contest presented by Diamonds Direct

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR CLAIM PRIZE. A PURCHASE WILL NOT INCREASE PARTICIPANTS' CHANCES OF WINNING. VOID WHERE PROHIBITED BY LAW. THIS CONTEST MAY NOT BE USED TO CONDUCT, ADVERTISE, OR PROMOTE ANY FORM OF GAMBLING.

1. ELIGIBILITY

The 2026 With This Diamond Contest presented by Diamonds Direct ("Contest") is open to legal residents of the State of Indiana who are 18 years of age or older as of the date of registration. Employees, officers, directors, agents, and representatives of the Indianapolis Colts, Inc. ("Club"), Diamonds Direct USA, Inc. ("Sponsor"), the National Football League ("NFL"), or any of their respective agencies, owners, subsidiaries, and affiliates, or the immediate family members (spouse, mother, father, sister, brother, daughter, son, grandson, or granddaughter, regardless of where they live), or members of their same households (whether related or not), or those individuals who have, in the previous six months, won any sweepstakes or prize sponsored by Club or Sponsor are not eligible to participate or win a prize. By entering, participants agree to these Official Rules and the decisions of Club, Sponsor, and the NFL (collectively, "Released Parties"), which shall be final and binding in all respects. The Contest is subject to all applicable federal, state, and local laws. Void where prohibited.

2. SWEEPSTAKES PERIOD

The Contest begins at 12:01 AM Eastern Time on September 14, 2026, and ends at 11:59 PM Eastern Time on October 30, 2026 ("Contest Period"). The Contest, and participation in the Contest, are subject to these Official Rules. All entries become the property of Sponsor or Club and will not be acknowledged or returned.

3. PRIZE

The Prize winner will receive a ring of Sponsor's choice with a maximum value of \$10,000.00, two tickets to the Colts home game versus the New York Giants on November 29, 2026, and the opportunity to propose to his or her significant other on the field during a game break (the "Prize"). Prize winner and his or her guest cannot already be married or engaged.

All costs and expenses associated with the acceptance and use of the Prize not specified herein as being awarded, including, but not limited to, all federal, state, and local taxes, are the winner's sole responsibility. Sponsor or Club are not responsible for the cancellation of any event. All Prize details are at the sole discretion of Sponsor or Club. The total approximate retail value of the Prize is no more than \$12,500.00. Registration is free. Limit one registration per Participant and per mobile number or email address.

Multiple submissions may result in disqualification. The use of scripts, macros, other automated means, or any other device to subvert the Entry Process is prohibited, and all such registrations will be void. In the event of a dispute as to the identity of a Participant based on the email address used at the time of registration, entry will be identified to the person named on the applicable registration form (regardless of whether that is the name of the authorized account holder of the email address from which said registration form was submitted), provided such individual is eligible according to these Official Rules. The Prize winner will be contacted no later than November 16, 2026, via the email address or phone number provided on the registration form. If a Prize winner does not acknowledge the Prize within 48 hours of notice, a qualified alternative winner will be randomly selected and notified until the Prize is claimed.
