2022 Caesars Entertainment and Indianapolis Colts "Pick 6" Sweepstakes

NOTE: All entries are digital. All capitalized terms in this paragraph are defined below in the detailed description of the various parts of the Promotion.

1. ELIGIBILITY.

The 2022 Caesars Entertainment and Indianapolis Colts "Pick 6" Sweepstakes ("Sweepstakes") is open to legal residents of the United States who are 21 years of age or older as of the date of registration. Must be 21 years of age to claim Prize. Any individuals (including but not limited to employees, consultants, independent contractors, and interns) who have, within the past six months, performed services for the Caesars Enterprise Services, LLC ("Sponsor"), Indianapolis Colts, Inc. 2. SWEEPSTAKES PERIOD.

The Sweepstakes, and participation in the Sweepstakes, are subject to these Official Rules. All entries become the property of Club and Sponsor (the "Released Parties") and will not be acknowledged or returned.

Weekly winners will each receive an autographed Colts item or Pro Shop Gift Card. Once Entry Process is complete, participant will receive one entry ("Entry") for that week's Periodic Sweepstakes. Limit one Entry per participant, per week, through Colts Mobile App Login.

Multiple submissions may result in disqualification. The use of script, macro, other automated means, or any other device to subvert the Entry Process is prohibited and all such registrations will be void. In the event of a dispute as to the identity of participant based on the e-mail address or Colts Mobile App Login submitted at the time of registration, entry will be awarded to the person named on the applicable registration form (regardless of whether that is the name of the authorized account holder of the email address or Colts Mobile App Login from which said registration form was submitted), provided such individual is eligible according to these Official Rules.

Released Parties are not liable for any error, omission, interruption, defect, or delay in any transmission or communication; or for any technical problem, including but not limited to any injury or damage to participant's or any other person's computer or mobile device related to or resulting from participation in this Sweepstakes; typographical, printing, or other errors in these Official Rules, in any Sweepstakesrelated advertisements or other materials; the administration of the Sweepstakes, the processing of entries, the selection or announcement of winners, or the distribution of prizes; tabulation, timing errors, or other errors of any kind whether mechanical, human, electronic, typographical, or otherwise.

5. WINNER SELECTION.

6. WINNER NOTIFICATION.

Prize Winners will be contacted each week via the e-mail address or telephone number provided on the registration form. If Prize Winners do not acknowledge the Prize within 48 hours of notice, an alternative winner will be randomly selected and notified until Prize is claimed. The prize winner, by acceptance of prize, except where legally prohibited, grants permission for Released Parties and their designees to use his/her name, address (city and state), photograph, voice, or other likeness, and prize information for advertising, trade, and promotional purposes without further compensation, except as an endorsement of any commercial product or enterprise other than Sponsor's or Club's in all media now known or hereafter discovered, worldwide in perpetuity, without notice or review or approval.

<u>9. TAXES.</u>
