## 2018 Anthem Blue Cross and Blue Shield "COLTS ANTHEM Helmet" Promotion Official Rules

Club, whose decisions will be final, will conduct the random drawing, selecting from eligible social posts with the **#GoColts** hashtag, and the entrant follows the particular Club social media platform in which the entry was submitted. The potential winners do not need to be present to win. Entries are subject to verification and are automatically void and will be rejected if entry contains errors or omissions. Potential winners will be notified by a Club representative via the Facebook, Instagram, or Twitter direct message. In the event a potential winner cannot be contacted within one business day, or does not respond, declines the prize, or is ineligible, an alternate potential winner(s) will be drawn at random from the remaining eligible entrants if time permits.
