

2022 Colts Transfer to Win Sweepstakes

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR CLAIM PRIZE. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED BY LAW. This Sweepstakes may not be used to conduct, advertise, or promote any form of gambling.

1. ELIGIBILITY.

The Indianapolis Colts 2022 Transfer to Win Sweepstakes (“Sweepstakes”) is open to legal residents of the United States who are 18 years of age or older as of the date of entry. Any individuals (including but not limited to employees, consultants, independent contractors, and interns) who have, within the past six months, performed services for the Indianapolis Colts, Inc. (“Club”), or the National Football League (“NFL”), or who won any sweepstakes or prize sponsored by Club, or any of their respective parents, subsidiaries, affiliates, or successor companies, and immediate family and household members thereof, are not eligible to enter. Additionally, any individuals transferring complimentary tickets, (including player and staff tickets), or tickets from sponsorship contracts or tagged broker accounts, are not eligible to enter. “Immediate family members” means parents, stepparents, children, stepchildren, siblings, stepsiblings, or spouses. “Household members” shall mean people who share the same residence at least three months in the preceding one calendar year. By participating in the Sweepstakes, each participant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of Club, which shall be final and binding in all respects. All applicable federal, state, and local laws apply.

2. SWEEPSTAKES PERIOD.

The Sweepstakes begins at 12:01 AM Eastern Time on September 23, 2022 and ends at 11:59 PM Eastern Time on January 8, 2023 (“Sweepstakes Period”). The Sweepstakes, and participation in the Sweepstakes, are subject to these Official Rules.

3. HOW TO ENTER.

Participants will be automatically entered to win by electronically transferring a mobile ticket to another guest (“Entry Process”). Participants can also enter by or opt out of the Sweepstakes by mailing their name, address, telephone number, email address, and game date to Indianapolis Colts, Inc., Attention “Colts Transfer to Win Sweepstakes”, 7001 West 56th Street, Indianapolis, Indiana 46254. Participants must transfer mobile tickets within 72 hours prior to the start time of each game. Mailed entries must be received within three business days of each game for which an entry is made. Entry is free. Limit one entry per Participant, per account, per game.

Multiple entries may result in disqualification. The use of scripts, macros, other automated means, or any other device to subvert the Entry Process is prohibited, and all such entries will be void. In the event of a dispute as to the identity of a Participant based on the mobile ticket account or email address used at the time of entry, said entry will be identified to the person named on the applicable entry form (regardless of whether that is

the name of the authorized account holder of the email address from which said entry form was submitted), provided such individual is eligible according to these Official Rules. Participants' personally identifiable information will be used only in accordance with Club's Privacy Policy, as posted on <http://www.colts.com/footer/privacy-policy>.

Club is not liable for any error, omission, interruption, defect, or delay in any transmission or communication; or for any technical problem, including but not limited to any injury or damage to Participant's or any other person's computer related to or resulting from participation in the Sweepstakes; typographical, printing, or other errors in these Official Rules, or in any Sweepstakes-related advertisements or other materials; the administration of the Sweepstakes, the processing of entries, the selection or announcement of winners, or the distribution of prizes; tabulation, timing errors, or other errors of any kind whether mechanical, human, electronic, typographical, or otherwise.

4. PRIZES.

Each prize winner will receive \$250.00 in food and beverage credit valid at Lucas Oil Stadium during any Club 2022 regular season home game (the "Prize").

All costs and expenses associated with the acceptance and use of the Prize not specified herein as being awarded, including, but not limited to, all federal, state, and local taxes, are the winner's sole responsibility. Club is not responsible for the cancellation of any event. All Prize details are at the sole discretion of Club. The total approximate retail value of each Prize is \$250.00 per home game. No transfer, assignment, or substitution of Prize (or portion thereof) is permitted except by Club, which reserve the right to substitute a Prize (or portion thereof) with one of comparable or greater value as determined by Club.

5. WINNERS SELECTION.

One Prize winner for each game will be randomly selected from all eligible entries received via the Entry Process by a staff member of Club. By participating, Participants agree to these Official Rules and to the decisions of Club, which shall be final and binding in all respects. Limit one Prize per Participant, per household, per game. Odds of winning depend on the total number of eligible entries received.

6. WINNER NOTIFICATION.

Each Prize winner will be contacted 24-48 hours prior to game time, via the email address provided via the Entry Process. If a Prize winner does not acknowledge the Prize within 24 hours of notice, an alternative winner will be randomly selected and notified until the Prize is claimed. Each Prize winner may be required to sign a Declaration of Eligibility, Release, and Indemnification that: (i) releases, indemnifies, and holds harmless, Club, its respective parents, affiliates, subsidiaries, successors companies, owners, officers, directors, employees, agents, assigns, and representatives from, and against, any and all harm, expense, loss, damage, liability, or injury resulting directly or indirectly from participating in the Sweepstakes or the award, receipt, possession, use, or misuse of any prize awarded in the Sweepstakes; (ii) contains the Prize winner's agreement to be bound by the Sweepstakes' Official Rules; and (iii) authorizes Club to use each of the Prize

winner's names, likenesses, photographs, voices, and biographical data for advertising, promotional, or any other purpose, in any media. If a Prize winner fails to sign a Declaration of Eligibility, Release, and Indemnification Form within three business days of receipt, the Prize winner may be disqualified.

7. MISCELLANEOUS

By entering the Sweepstakes, each Participant agrees that: (i) Club and their designees may use (unless prohibited by law) each Participant's names, residential locations, photographs, or likenesses for advertising, promotional trade, or any other purposes in any media now, or hereafter, known throughout the world in perpetuity, without further compensation, permission, or notification except as an endorsement of any commercial product or enterprise other than Club's; and (ii) Club and its affiliates, subsidiaries, owners, officers, directors, employees, agents, and assigns shall have no liability and will be held harmless, discharged, and released by each Participant from any claim, action, liability, loss, injury, or damage to Participant or any other person or entity, including, without limitation, personal injury or death to Participant, or any other person, or damage to personal or real property, due in whole, or in part, directly or indirectly, by reason of the Participant's participation in the Sweepstakes, or Participant's acceptance, possession, use, or misuse of the Prizes, or participation in the Sweepstakes, even if the loss, injury, or damage is caused by Club's ordinary negligence.

Club in its sole discretion, may: (i) disqualify any person who tampers with the Entry Process or any other component of the Sweepstakes, or who is otherwise in violation of these Official Rules; (ii) modify, suspend, or terminate the Sweepstakes (or any portion thereof) for any reason, including, but not limited to, a virus, bug, non-authorized human intervention, war, strikes, pandemic, acts of God, or any other cause which may corrupt or impair the administration, security, fairness, or proper play of the Sweepstakes; and (iii) in the event of termination, in their discretion, award prizes for completed portions of the Sweepstakes (or applicable portions of the Sweepstakes) to the next eligible Participant (as determined by Club) as of the date of the event requiring such termination in accordance with these Official Rules.

Club will be collecting personal data about Participants online, in accordance with its privacy policy, as posted on <https://www.colts.com/footer/privacy-policy> and attached to these Official Rules as Exhibit A. By participating in the Sweepstakes, Participants consent to Club's collection and use of their personal information and acknowledge that they have read and accepted Club's privacy policy. Each Prize winner, by acceptance of the Prize, except where legally prohibited, grants permission for Club and its designees, to use their names, residential locations, photographs, voices, or other likenesses, and

Prize information for advertising, trade, and promotional purposes without further compensation, except as an endorsement of any commercial product or enterprise other than or Club's, in all media now known, or hereafter discovered, worldwide in perpetuity, without notice, review, or approval.

9. TAXES

Any valuation of the Prize stated above is based on available information provided to Club, and the value of any prize awarded to a winner may be reported for tax purposes as required by law. Prize winner is solely responsible for reporting and paying, any and all applicable taxes. Prize winner must provide Club with valid identification, a valid taxpayer identification number, or social security number before any prize will be awarded. Any person winning over \$600.00 in prizes from Club will receive an IRS form 1099 after the end of the calendar year, and a copy of such form will be filed with the IRS.

10. DISPUTES
