

**WASHINGTON COMMANDERS FOUNDATION
2026-27 NFL SEASON 50/50 RAFFLE
OFFICIAL RULES (EFFECTIVE AUGUST 3, 2026)**

This 50/50 raffle (the “Raffle”) is open only to legal residents of the United States eighteen (18) years of age or older by August 13, 2026. Void in New York, Florida, outside the United States, and where prohibited.

Employees, raffle sellers, agents, and representatives of (i) Washington Commanders Foundation, Inc. (“WCF”) or (ii) any of the Released Parties (as defined below), and each of their respective immediate Family Members, other Family Members, and household members, shall not be eligible to enter or win (including in the draw for Early Bird Draw Prizes (as defined below)). For purposes of this provision, “Family Members” shall include any individual related by blood, marriage, affinity, domestic partnership, adoption, guardianship, or step-relationship, whether such relationship is immediate, remote, direct, or collateral, including, without limitation, parents, children, spouses, siblings, grandparents, grandchildren, aunts, uncles, nieces, nephews, cousins, and any and all in-laws, regardless of where they reside. Any person residing in the same household as any such employee, raffle seller, agent, or representative, whether or not related, shall likewise be ineligible to enter or win. By participating, entrants agree to be bound by these official rules (“Official Rules”) and the decisions of the judges and/or WCF, which shall be final and binding in all matters relating to the Raffle. The Raffle is subject to all applicable federal, state and local laws. The Raffle shall be conducted by means of a random drawing for each National Football League (“NFL”) game in which the Washington Commanders participates during the 2026-27 NFL season (“Game”), from which one (1) winner shall be selected.

TIMING: The Raffle begins the Thursday prior to the start of the designated home or away Game and ends during the middle of the fourth quarter of the designated home or away Game (the “Promotion Period”). A random drawing to determine one (1) prize winner will be held at the end of the Promotion Period. The winning number will be posted on the Raffle website. The winner will have seven (7) days to claim the Raffle prize by contacting the phone number listed on all tickets for the Raffle.

ANY RAFFLE ENTRY RECEIVED AFTER THE CLOSE OF THE PROMOTION PERIOD WILL NOT BE ACCEPTED.

HOW TO ENTER: To enter, visit the Raffle website or purchase a ticket from a WCF representative at the following location during the Promotion Period: 1600 Ring Road, Landover, MD 20785. Entrants will have the option of purchasing via credit card only 5 tickets for \$10, 20 tickets for \$20.00 total, 150 tickets for \$50.00 total, or 400 tickets for \$100.00 total.

A raffle entry is not received until the above task is completed by the participant. All raffle entries must be received by the end of the Promotion Period to be eligible.

RANDOM DRAWING: One (1) winner will be selected in a random drawing at the end of the Promotion Period from among all eligible entries received during the Promotion Period. Odds of winning depend on the number of eligible entries received. The drawing will be conducted by a WCF representative. WCF holds the right to disseminate the winner’s name via the team’s Twitter accounts, Facebook accounts, and any or all of WCF’s social media platforms. The winner need not be present at the drawing.

WINNER NOTIFICATION: The winning number will be posted on the Raffle website. The winner will have seven (7) days to claim the Raffle prize by contacting the phone number listed on all tickets. Except

where prohibited by law, entry constitutes permission to use winner's names, hometowns and likenesses for online posting, and/or any advertising and publicity without additional compensation. Both the entrant and entrant's guest(s), if applicable, (or, where the potential winner is a minor, his/her parent or legal guardian) may be required to complete, sign and return an affidavit of eligibility, a liability release and, where lawful, a publicity release within thirty (30) days of issuance. If such documents are not returned within the specified period time period, a prize/prize notification is returned as undeliverable, or if a winner is not in compliance with these Official Rules, the prize will be forfeited and, at WCF's discretion and time permitting, an alternate winner selected. If a potential winner is eligible but considered a minor in his or her state of permanent residence, WCF reserves the right to award the prize in the name of his/her parent or legal guardian who will be required to execute and return the affidavit/release and all other required documents on winner/minor's behalf as well as comply with any other requirements imposed on winner set forth herein.

PRIZES: Amount of prize awarded will be dependent on the size of the proceeds collected during the Promotion Period. The winner will receive fifty percent (50%) of the net proceeds during the Promotion Period in which their winning number is selected. Participants are eligible to win one (1) time during the Promotion Period.

GENERAL PRIZE CONDITIONS: The winner agrees that the prize is awarded "as is" with no warranty, representation or guarantee, either express or implied, in fact or in law, whether now known or hereinafter enacted, relative to the use or enjoyment of the prize, including, without limitation, its quality, merchantability or fitness for a particular purpose. All prize details are at WCF's sole discretion. The winner is responsible for all applicable federal, state and local taxes, if any and all other costs associated with prize acceptance and use not specified herein as being provided regardless of whether the winner chooses to accept the Prize or the Prize's cash equivalent. WCF will not replace any lost, mutilated, or stolen prizes or any prize that is undeliverable or does not reach the winner for any reason, including, without limitation, because of incorrect or changed contact information. No more than the stated prizes will be awarded. All prizes legitimately claimed will be awarded. If a winner cannot accept prize as stated, prize will be forfeited and, at WCF's discretion, an alternate winner selected.

EARLY BIRD DRAWS: WCF may, in its sole and absolute discretion, conduct select early bird draws throughout the Raffle ("Early Bird Draw(s)"). For Games that also have Early Bird Draws, all tickets purchased for the Raffle prior to the designated Early Bird Draw closing time will be eligible, and automatically entered, to win all Early Bird Draw prizes ("Early Bird Prize(s)").

The winning ticket number for an Early Bird Prize will remain eligible for any subsequent Early Bird Draws for that Game, unless otherwise stated in the applicable Game rules. In addition, each winning ticket number for an Early Bird Prize will remain entered in the draw for the applicable Raffle prize for which the ticket was purchased.

The winner notification for the winning ticket number of Early Bird Prizes will be posted on the Raffle website shortly after the Early Bird Draw and will follow the winner notification process under the WINNER NOTIFICATION paragraph of these Official Rules.

Early Bird Prizes will not be transferable and must be accepted as awarded with no substitutions, except at WCF's sole discretion.

Any requirements, conditions, or procedures not expressly set out in this paragraph will be governed by these Official Rules.

GENERAL CONDITIONS: Released Parties are not responsible for lost, late, incomplete, inaccurate, stolen, misdirected, undelivered, garbled, illegible entries; or for technical failure or other errors or difficulties of any kind whether human, typographical, printing or otherwise relating to or in connection with the Raffle, including, without limitation, errors or difficulties which may occur in connection with the administration of the Raffle, the processing of entries, the announcement of the prizes and the winners, or in any related materials of the Raffle. Released Parties are also not responsible for any incorrect or inaccurate information. Released Parties are not responsible for injury or damage to participants' or any person's computer related to or resulting from participating in the Raffle. Persons who tamper with or abuse any aspect of the Raffle, act in an unsportsmanlike or disruptive manner, or who are in violation of these Official Rules, as solely determined by WCF, will be disqualified and all associated entries will be void. WCF reserves the right at its sole discretion to suspend or modify the Raffle should any portion of the Raffle be, in WCF's sole opinion, compromised by non-authorized human intervention or other causes which, in the sole opinion of the WCF, corrupt or impair the administration, security, fairness or proper play, or submission of entries, or for any other reason determined by WCF in its sole discretion and, if terminated, at its discretion, select the potential winner(s) for the drawing(s) at issue from all eligible, non-suspect entries received for the applicable drawing prior to action taken or as otherwise deemed fair and appropriate by WCF. WCF is not responsible for electronic communications that are undeliverable as a result of any form of active or passive filtering of any kind, or insufficient space in entrant's e-mail account to receive e-mail messages. WCF is not responsible, and may disqualify an entrant, if his or her e-mail address, telephone, or other contact information does not work or if it is changed without entrant giving prior written notice to WCF. WCF's failure to or decision not to enforce any provision in these Official Rules will not constitute a waiver of that or any other provision. In the event there is an alleged or actual ambiguity, discrepancy or inconsistency between disclosures or other statements contained in any related materials for the Raffle and/or these Official Rules (including any alleged discrepancy or inconsistency in these Official Rules), it will be resolved in WCF's sole discretion. The invalidity or unenforceability of any provision of these Official Rules shall not affect the validity or enforceability of any other provision. In the event that any provision is determined to be invalid or otherwise unenforceable or illegal, these Official Rules shall otherwise remain in effect and shall be construed in accordance with their terms as if the invalid or illegal provision were not contained herein. If WCF determines at any time in its sole discretion that the winner or potential winner is disqualified, ineligible, or in violation of these Official Rules, WCF reserves the right in its sole discretion to select an alternate winner, even if the disqualified potential winner's name may have been shown or announced publicly. If any person supplies false information, obtains entries by fraudulent means or is otherwise determined to be in violation of these Official Rules in an attempt to obtain any prize, WCF may disqualify that person and seek damages from him or her and that person may be prosecuted to the full extent of the law. Entrants, by participating, agree that the Washington Commanders Foundation, Inc., WFI Stadium LLC, ProFootball LLC d/b/a the Washington Commanders, Scoreboard HoldCo LLC, Scoreboard HoldCo II LLC, the NFL Entities (as defined below), and each of their respective parents, affiliates, subsidiaries and related parties, and advertising and promotion agencies and all of their respective officers, directors, members, managers, contractors, employees, representatives and agents (collectively, "Released Parties") will have no liability whatsoever for, and shall be held harmless by entrants against, any liability, for any injuries, losses or damages of any kind, including death, to persons, or property resulting in whole or in part, directly or indirectly, from acceptance, possession, misuse, awarding or use of any prize (including any activity related thereto) or while preparing for, participating in and/or traveling to or from any prize- or sweepstakes-related activity. The "NFL Entities" shall be defined as the NFL, its member professional football clubs, NFL Ventures, Inc., NFL Ventures, L.P., NFL Properties LLC, NFL Enterprises LLC, and each of their respective subsidiaries, affiliates, shareholders, officers, directors, agents, representatives, and employees. CAUTION: ANY ATTEMPT TO DELIBERATELY DAMAGE OR

UNDERMINE THE LEGITIMATE OPERATION OF THE RAFFLE IS A VIOLATION OF CRIMINAL AND CIVIL LAWS AND SHOULD SUCH AN ATTEMPT BE MADE, WCF WILL DISQUALIFY ANY SUCH INDIVIDUAL AND RESERVES THE RIGHT TO SEEK DAMAGES (INCLUDING ATTORNEYS' FEES) AND OTHER REMEDIES FROM ANY SUCH INDIVIDUAL TO THE FULLEST EXTENT PERMITTED BY LAW.

DISPUTES: Any controversy, dispute, or claim regarding the performance or interpretation of these Official Rules shall be resolved by confidential and binding arbitration, at the request of either party, in accordance with JAMS Streamlined Arbitration Rules and Procedures, with such arbitration to be conducted in Washington, D.C., and apply the laws of the Commonwealth of Virginia and applicable rules of evidence under JAMS (or rules of evidence as otherwise agreed to between the parties and approved by the arbitrator(s)) with respect to any claims. The parties hereby waive their right to a jury trial. Except where prohibited, as a condition of participating in the Raffle, each entrant agrees that any and all disputes that cannot be resolved between the entrant and any Released Party, claims and causes of action arising out of or connected with the Raffle, or the prize awarded, or the determination of the winner must be resolved individually, without resort to any form of class action. Further, in any such dispute, under no circumstances will an entrant be permitted or entitled to obtain awards for, and hereby waives all rights to claim punitive, incidental or consequential damages, or any other damages, including attorneys' fees, other than entrant's actual out-pocket expenses (if any), not to exceed two hundred fifty dollars (\$250), and entrant further waives all rights to have damages multiplied or increased. The parties shall keep all aspects of an arbitration proceeding, including, without limitation, an arbitration award and any evidence, documents, or information exchanged during such proceeding, strictly confidential.

CHOICE OF LAW: All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of participant and WCF in connection with these Official Rules, shall be governed by, and construed in accordance with, the substantive laws of the State of Maryland.
