## <u>Dallas Cowboys Wings & Dreams Art Contest</u> CONTEST RULES

## NO PURCHASE NECESSARY TO ENTER OR WIN. VOID WHERE PROHIBITED.

**Eligibility:** 12<sup>th</sup> grade Texas high school students within Frisco ISD, Prosper ISD, Plano ISD and Arlington ISD who are enrolled and in good standing during the Contest Period "Entrant".

Employees of Wingstop Restaurants Inc. "Sponsor", Sponsor's franchisees, and the DCFC (as defined below), and their respective parents, affiliates, subsidiaries, advertising or promotion agencies, or other individuals engaged in the development, production, or distribution of promotion materials, and persons who are immediate family members of or who reside in the same household as persons in the preceding categories, are not eligible to participate.

## **Submission Content Restrictions:**

- Submissions must be original works created solely by the Entrant and must not contain content created by a third party, such as images or artwork;
- Submissions must not contain material that violates or infringes another's rights, including but not limited to privacy, publicity, or intellectual property rights, or that constitutes infringement;

**To win:** Between March 2-6, 2021, a panel of judges comprised of impartial representatives from both Sponsor and the DCFC, as determined by Sponsor in its sole discretion, shall review all

eligible Submissions on a "blind" basis (i.e., the judges will not know the identity of the Entrants associated with the respective Submissions) and select five (5) semi-finalist ("Semi-Finalists") from all eligible Submissions based on the following equally-weighted criteria: creativity, originality, and how effectively the Submission showcases the entrant's dreams, goals and leadership. In the event of a tie, the Entrant with the highest score in the "originality" category will be the winner. Sponsor shall create a poster or similar visual featuring the Semi-Finalists to be displayed in certain Wingstop restaurants, online at dallascowboys.com and Dallas Cowboys Facebook and Twitter, public votes may be submitted via these locations during the Public Voting Period. On or around May 1, 2021, a new panel of judges comprised of impartial representatives from both Sponsor and the DCFC, as determined by Sponsor in its sole discretion, and which shall not include any of the judges from the earlier panel, shall select (1) Grand Prize Winner and two (2) Runner-up Winners (each a "Winner", collectively "Winners") in its sole discretion based on the following equally-weighted criteria: creativity, overall visual appeal, how effectively the Submission showcases the entrant's dreams, goals and leadership, and public appeal as represented by the Public Voting. In the event of a tie, the Entrant with the highest score in the "originality" category will be the winner. Submissions not within the parameters will not be included in the judging process. Sponsor will notify Winners and make Winner announcements in its sole discretion.
