ELIGIBILITY:** The Miami Dolphins Draft the Best Sweepstakes ("Sweepstakes") is open only to legal residents of the state of Florida who are 18 years of age or older as of as of March 11th, 2019. Limit one (1) entry per person/email address, per day, during the Sweepstakes Period. All entries become the property of Administrator and will not be acknowledged or returned.
- 3. PRIZE:** One (1) winner will be selected.
