

**Snyder's-Lance "Ultimate VIP Snacking Experience 11/04/18" Sweepstakes  
Official Rules**

- 1. SPONSOR & ADMINISTRATOR:** The sponsor of this Snyder's-Lance "Ultimate VIP Snacking Experience 11/04/18" Sweepstakes ("Sweepstakes") is S-L Snacks National, LLC, 13515 Ballantyne Corporate Place, Charlotte, North Carolina 28277 ("Sponsor"). - 2. ELIGIBILITY:** This Sweepstakes is open only to legal residents of Florida, who are at least 21 years old at the time of entry. Employees, officers and directors or agents of Sponsor, Administrator, Miami Dolphins, Ltd., the South Florida Stadium, LLC, and their respective subsidiaries, divisions, affiliates, parent companies, and agencies (collectively the "Sweepstakes Entities"), the NFL Entities (defined in Section 12 below), as well as immediate family (parents, siblings, children, and their respective spouses) and residents of their households (whether related or not) are not eligible to enter. This Sweepstakes is subject to all applicable federal, state, and local laws and regulations and is void where prohibited. DRAWING; ODDS; NOTIFICATION OF WINNER:** On or about ,October 26, 2018 Administrator will randomly select one (1) potential Grand Prize winner from all eligible entries received during the Entry Period. Odds of winning prize depend on the number of eligible entries received during the Entry Period. Administrator will notify potential winner by email or phone, in its discretion. Entrant consents to be contacted by email or phone by Sponsor and Administrator for purposes of this Sweepstakes. Potential winner must respond within three (3) business days of initial notification. Winner will be required to sign, have notarized and return an Affidavit of Eligibility and Liability / Publicity Release and an IRS Form W-9 (Request for Tax Payer Identification) ("Winner Documents") within no less than seven (7) business days of the date of such Winner Documents in order to claim prize. Winner may also be required to provide a copy of their driver's license with the Winner Documents.
