

SNAPPLE FRESH FOR TRAINING CAMP SWEEPSTAKES OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED OR RESTRICTED BY LAW.

1. Eligibility

The Snapple Fresh For Training Camp Sweepstakes ("Sweepstakes") is offered only in the United States to legal residents of Delaware, New Jersey and Pennsylvania who are eighteen (18) years of age or older as of the date of registration. Employees, officers, directors, agents and representatives of Philadelphia Eagles, LLC (the "Eagles"), Snapple Beverage Corp. ("Snapple"), Wawa, Inc. Sweepstakes period begins on June 9, 2019 at 12:00:00 p.m. Eastern Time, and ends on June 30, 2019 at 11:59:59 a.m. Eastern Time (the "Sweepstakes Period"). There will be one (1) drawing after the end of the Sweepstakes Period.

3. Entry

You may enter the Sweepstakes by going to www.philadelphiaeagles.com/snappletrainingcamp (the "Website") during the Sweepstakes Period and entering your name, address (no P.O. Boxes accepted), email address, daytime telephone number with area code, confirming that you are eighteen (18) years or older and agreeing to the Official Rules, and subject to the conditions below, you will be automatically entered into the Sweepstakes.

LIMIT ONE (1) ENTRY PER PERSON DURING THE SWEEPSTAKES PERIOD. If multiple entries are received, only the first entry will be entered into the sweepstakes and all other entries will be disregarded. 4. Drawing

One (1) drawing will be held on or about July 1, 2019 and will be conducted by the Eagles. Ten (10) Winners will be selected randomly from all eligible entries **received on or prior to 12:00:00 p.m. Eastern Time on June 30, 2019.** Limit one (1) prize per Entry. The potential winners will be notified by the Eagles within approximately three (3) days of the random drawing via e-mail, telephone, or any such other method determined by Eagles in its sole discretion. If, after two (2) attempts, contact has not been made, the prize will be forfeited and an alternate winner will randomly be selected from the eligible entries received during the Sweepstakes Period. Fulfillment agent must speak with the potential winner.

5. Prize/Odds

In accordance with these Official Rules, each Winner will receive admission for Winner and one (1) Guest to attend a Philadelphia Eagles training camp practice at the NovaCare Complex (the “Event”) at a time and date to be determined by the Eagles in its sole discretion (approximate retail value: \$200.00 each; \$2,000 total). Any other costs associated with attendance at the Event shall be the sole responsibility of the winner. All winners and guests attending the Event must comply with the Eagles Fan Code of Conduct for Training Camp. **Odds of winning will be determined by the total number of entries received during the Sweepstakes Period.** Limit one (1) prize per person.
