

## **DIETZ & WATSON MEAT THE ROOKIES SWEEPSTAKES OFFICIAL RULES**

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED OR RESTRICTED BY LAW.**

### **1. Eligibility**

Sweepstakes is offered only in the United States to legal residents of Delaware, New Jersey, and Pennsylvania who are eighteen (18) years of age or older, as of the date of entry. Employees, officers, directors, agents and representatives of Philadelphia Eagles, LLC (the “Eagles”), Dietz & Watson, Inc. ### **3. Entry**

You may enter by going to <https://forms.philadelphiaeagles.com/f/dietzsweeps>, entering your date of birth and country of residence and then entering your first name, last name, e-mail address, state of residence, zip code, and confirming that you have read and agree to the Official Rules. Upon completing the entry method, and subject to the conditions below, you will automatically be entered into the Sweepstakes. Proof of entry submission does not equate to proof of receipt. Entrants agree to be bound by the Official Rules.

#### **4. Drawing**

One (1) drawing in total will be conducted by the Eagles following the conclusion of the Sweepstakes Period and held on or about June 2, 2025. One (1) winner will be selected randomly by the Eagles from all eligible entries received during the Sweepstakes Period. Winner of the drawing will be notified by e-mail within approximately one (1) day of the drawing. If, after two (2) attempts, contact has not been made, prize will be forfeited, and an alternate winner may be randomly selected from the eligible entries received during the Sweepstakes Period. Fulfillment agent must speak with potential winner. Final designation as the winner depends on verification of eligibility as determined by Sponsor.

#### **5. Prize/Odds**

In accordance with these Official Rules, one (1) winner will be awarded the following prize: four (4) tickets (ARV \$200) and four (4) pre-game sideline passes (ARV \$260) to a home game in which the Eagles play during the 2025 NFL pre-season at Lincoln Financial Field (the "Event") and an autographed authentic Eagles helmet (ARV \$190). Total ARV \$650. Player autograph and Eagles pre-season home game and seat locations to be determined by Eagles in its sole discretion.
