

2026 EAGLES TICKETS AND FANDUEL PASSES SWEEPSTAKES – OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED OR RESTRICTED BY LAW.

BY CHECKING THE OPTIONAL AGREEMENT TO RECEIVE AUTOMATED PROMOTIONAL AND PERSONALIZED MARKETING COMMUNICATIONS BOX UPON ENTERING THE SWEEPSTAKES, YOU AGREE TO RECEIVE SUCH COMMUNICATIONS FROM EAGLES VIA THE PHONE NUMBER PROVIDED IN YOUR ENTRY, REGARDLESS OF WHETHER YOU ARE SELECTED AS THE POTENTIAL WINNER. 1. Eligibility

The 2026 Eagles Tickets and FanDuel Passes Sweepstakes (“Sweepstakes”) is offered only in the United States to legal residents of the fifty (50) United States and the District of Columbia, except New York, Florida and Rhode Island, who are eighteen (18) years of age or older (or the age of majority in the jurisdiction in which they reside, whichever is older) as of the date of entry. Employees, officers, directors, agents and representatives of Philadelphia Eagles, LLC (“Eagles”) and any of its agencies, owners, subsidiaries and affiliates, advertising and promotion agencies, wholesale distributors, and individual retail licensees or the immediate family (spouse, mother, father, sister, brother, daughter, son, grandson or granddaughter, regardless of where they live) or members of their same households (whether related or not) of each such individuals are not eligible to participate or win a prize. By entering, you agree to these Official Rules and the decisions of the Eagles (the judging organization), which are final and binding in all respects.

2. Sweepstakes Period

Sweepstakes period begins on Friday, August 21, 2026 at 12:00 p.m. Eastern Time (“ET”) and ends on Monday, September 21, 2026 at 12:00 p.m. ET (the “Sweepstakes Period”). The Eagles’ computer shall be the official clock of the Sweepstakes.

3. Entry

You may enter by going to <https://fanexperience.nfl.com/eagles/sms-opt-in-sweepstakes.html>, clicking on the icon to access the entry form during the Sweepstakes Period and entering your e-mail address, first and last name, date of birth, country of residence, zip code, and confirm that you have read and agree to the Official Rules. Prior to submitting your entry, you may opt-in to receive recurring automated promotional and personalized marketing communications from Eagles via SMS messages. If you agree to the optional agreement, you will be required to enter your phone number on the entry form. Upon completing the entry method, and subject to the conditions below, you will automatically be entered into the Sweepstakes and receive one (1) entry. Proof of entry submission does not equate to proof of receipt. Entrants agree to be bound by the Official Rules.

4. Winner

Following the conclusion of the Sweepstakes Period, one (1) winner will be selected randomly by the Eagles from all eligible entries received during the Sweepstakes Period (the "Winner"). Winner will be notified by e-mail on or about September 22, 2026. If, after two (2) attempts contact has not been made, prize will be forfeited and an alternate winner may be randomly selected from the eligible entries received during the Sweepstakes Period. Final designation as the winner depends on verification of eligibility as determined by Eagles. Winner may not substitute or redeem prize for cash, but the Eagles reserves the right to substitute prize with a prize of equal or greater value should the advertised prize become unavailable for any reason.

5. Prize/Odds

In accordance with these Official Rules, one (1) Winner will be awarded the following prize: two (2) game tickets (Approximate Retail Value ("ARV"): \$600 (\$300/ticket)) and two (2) FanDuel Lounge Passes (ARV: \$450 (\$225/pass)) to one (1) Philadelphia Eagles home game scheduled to take place at Lincoln Financial Field during the 2026 NFL regular season (the "Game"). Total ARV of the prize is \$1,050.

Seat locations to be determined by Eagles in its sole discretion. Winner's guest must be eighteen (18) years of age or older. Travel expenses and any other costs associated with attendance at the Game, including without limitation meals, tips and gratuities, taxes and fees associated with the receipt and/or use of the tickets, shall be the sole responsibility of Winner. Eagles reserves the right to remove or deny entry to any event or component of the prize if, in its sole discretion, the Winner's behavior or the behavior of such individual's guest is disruptive, belligerent, abusive, intended to annoy, threaten or harass, any other person at the venue or event. Under such circumstances, the individual (and/or guest) may be asked to leave and may forfeit all remaining portions of the prize. Tickets are subject to certain terms and conditions as specified therein. Resale of tickets is prohibited.
