

## ROAD TO VICTORY SWEEPSTAKES – OFFICIAL RULES

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED OR RESTRICTED BY LAW.**

### 1. Eligibility

The Road to Victory Sweepstakes (“Sweepstakes”) is offered only in the United States to legal residents of the fifty (50) United States and the District of Columbia, except New York, Florida and Rhode Island, and who are eighteen (18) years of age or older (or the age of majority in the jurisdiction in which they reside, whichever is older) as of the date of entry. Employees, officers, directors, agents and representatives of Philadelphia Eagles, LLC (“Eagles”), Ticketmaster L.L.C. (“Ticketmaster”), Comcast SportsNet Philadelphia, L.P. d/b/a NBC Sports Philadelphia, NBCUniversal Media, LLC (“NBC”) and any of their respective agencies, owners, subsidiaries and affiliates, advertising and promotion agencies, wholesale distributors, and individual retail licensees or the immediate family (spouse, mother, father, sister, brother, daughter, son, grandson or granddaughter, regardless of where they live) or members of their same households (whether related or not) of each such individuals are not eligible to participate or win a prize. ### 2. Sweepstakes Period

Sweepstakes period begins on Wednesday, January 10, 2024 at 12:00:00 p.m. Eastern Time (“ET”) and ends on Monday, January 15, 2024 at 7:59:59 p.m. ET (the “Sweepstakes Period”). The Eagles’ computer shall be the official clock of the Sweepstakes.

### 3. Entry

There are two (2) ways to enter during the Sweepstakes Period:

1. During the Sweepstakes Period, you may enter by scanning the QR code located on NBC’s Road to Victory Bus traveling throughout Pennsylvania on Thursday, January 11, 2024. Upon scanning the QR code, an entrant will be taken to <https://www.philadelphiaeagles.com/fans/sweepstakes/roadtovictory>, where they can enter into the Sweepstakes by completing the entry form with the following information: first name, last name, email address, and zip code, checking the box that you agree to the Official Rules and are eighteen (18) years of age or older as of the date of registration. Subject to the conditions below, you will automatically be entered into the Sweepstakes. The Eagles’ computer shall be the official clock of the Sweepstakes.
2. During the Sweepstakes Period, you may enter by going to <https://www.philadelphiaeagles.com/fans/sweepstakes/roadtovictory>, clicking on the icon to access the entry form during the Sweepstakes Period and entering your first name, last name, email address, and zip code, checking the box that you agree to the Official Rules and are eighteen (18) years of age or older as of the date of registration. Subject to the conditions below, you will automatically be entered into the Sweepstakes. The Eagles’ computer shall be the official clock of the Sweepstakes.

**LIMIT ONE ENTRY PER PERSON DURING SWEEPSTAKES PERIOD (REGARDLESS OF WHETHER MORE THAN ONE PERSON USES THE SAME E-MAIL ACCOUNT).** If more than one entry is submitted, only the first entry will be entered into the Sweepstakes and all other entries will be disregarded. holder of the e-mail address used to enter will be deemed to be the entrant. The “authorized account holder” is the natural person assigned an e-mail address by an Internet access provider, online service provider or other organization responsible for assigning e-mail addresses for the domain associated with the submitted address. The potential winner(s) may be required to show proof of being the authorized account holder.

Any attempt by any person to submit more than the stated number of entries by using multiple/different accounts or any other methods will void that person’s entry and that person will be disqualified. Automated entries (including but not limited to any entries submitted using any robot, script, macro or other automated service) are not permitted and will be disqualified.

No responsibility is assumed for lost, late, incomplete, stolen, misdirected or illegible entry; or for any computer, telephone, cable, network, satellite, electronic or Internet hardware or software malfunctions, failures, connections, availability or garbled or jumbled transmissions, or service provider/Internet/Web site/use net accessibility or availability, traffic congestion, or unauthorized human intervention. No mass entries or mechanically reproduced entries will be accepted. All entries become the exclusive property of the Eagles and will not be returned or acknowledged. Any attempts by an individual to access the Sweepstakes via a bot script or other brute-force attack will result in that IP address becoming ineligible. The Eagles will prosecute any fraudulent activities to the fullest extent of the law. The Eagles reserves the right to suspend or terminate this Sweepstakes without notice if, in the Eagles sole discretion, the Sweepstakes becomes infected or otherwise corrupted.

#### **4. Winner**

One (1) drawing in total will be conducted by the Eagles following the conclusion of the Sweepstakes Period and held on or about Wednesday, January 17, 2024. One (1) winner will be selected randomly by the Eagles from all eligible entries received during the Sweepstakes Period. Winner will be notified by e-mail within approximately two (2) days of the drawing. If, after two (2) attempts contact has not been made, prize will be forfeited and an alternate winner may be randomly selected from the eligible entries received during the Sweepstakes Period. Final designation as the winner depends on verification of eligibility as determined by Eagles. Winner may not substitute or redeem prize for cash, but the Eagles reserves the right to substitute prize with a prize of equal or greater value should the advertised prize become unavailable for any reason.

#### **5. Prize/Odds**

In accordance with these Official Rules, one (1) winner will be awarded the following prize: two (2) tickets and two (2) Ticketmaster Tunnel Club passes to a home game in which the Philadelphia Eagles play at Lincoln Financial Field during the 2024 NFL regular season (ARV \$770) and one (1) autographed Eagles miniature helmet (ARV \$30). Total approximate retail value (\$800). Seat locations and player autograph to be determined by Eagles in its sole discretion.

**Odds of winning will be determined by the total number of eligible entries received during the Sweepstakes Period.** No assignment, transfer or substitution of prize is permitted except by the Eagles in the event of prize unavailability. Travel expenses and any other costs associated with attendance at the game shall be the sole responsibility of winner. If the winner’s guest is a minor, the winner must be the parent or legal guardian of such guest. Taxes on or connected with the prize and the reporting consequences thereof are the sole and exclusive responsibility of winner.

## **6. General Conditions**

Winner may be required to execute and return an Affidavit of Eligibility, a Liability Release, and where lawful, a Publicity Release within five (5) days of notification of the prize.
