

**2022 PLAYOFFS EAGLES KIDS CLUB FAN OF THE GAME CONTEST**  
**OFFICIAL RULES**

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED OR RESTRICTED BY LAW.**

**1. Eligibility**

Contest is offered only to legal residents of Pennsylvania, New Jersey, Delaware and Maryland who are parents or legal guardians of children between the ages of 5 and 12 as of the date of registration. Employees, officers, directors, agents and representatives of Philadelphia Eagles, LLC (the “Eagles” or “Sponsor”) and any of its agencies, owners, subsidiaries and affiliates, or the immediate family (spouse, mother, father, sister, brother, daughter, son, grandson or granddaughter, regardless of where they live) or members of their same households (whether related or not) of each such individuals are not eligible to participate or win a prize. By entering, you agree to these Official Rules and the decisions of the Eagles (the judging organization), which are final and binding in all respects.

**2. Contest Period**

Contest period begins on Friday, January 6, 2023 at 12:00:00 p.m. Eastern Time (“ET”) and ends at 11:59 p.m. ET on the Tuesday prior to the final home game in which the Eagles play during the 2022 NFL playoffs (the “Contest Period”). There will be up to three (3) entry periods (each, an “Entry Period”) during the Contest Period as set forth in the chart below, and one (1) winner will be selected following the conclusion of each Entry Period.

**3. Entry**

There are two (2) ways to enter during the Contest Period:

1.) Parent or legal guardian may enter your child by going to the Kids Club page of [www.philadelphiaeagles.com](http://www.philadelphiaeagles.com) and clicking on the icon to access the entry form during the Contest Period. A Parent or legal guardian MUST complete the Official Entry Form on behalf of your child by entering your child’s name, your name, your address (no P.O. Boxes accepted), your e-mail address, your daytime telephone number with area code, your child’s age and checking the box that you agree to the Official Rules and your child is an Eagles Kids Club member. Next, upload a photograph of your child that shows how big of an Eagles fan your child is. Subject to the conditions below, your child will automatically be entered into the Contest. Parents and legal guardians can sign up their children for the Kids Club at [www.philadelphiaeagles.com/kidsclub](http://www.philadelphiaeagles.com/kidsclub). Proof of entry submission does not equate to proof of receipt. Entrants agree to be bound by the Official Rules.

2.) Parent or legal guardian may enter your child by mailing the information described in (1) above during the Contest Period in a standard envelope to 2022 Playoffs Eagles Kids Club Fan of the Game Contest, c/o Marketing, NovaCare Complex, One NovaCare Way, Philadelphia, PA 19145. Subject to the conditions below, your child will automatically be entered into the Contest. Proof of entry submission does not equate to proof of receipt. Entrants agree to be bound by the Official Rules.

One (1) winner will be selected by the close of business on the Wednesday prior to each Eagles home playoff game based on the photographs that show the biggest Eagles fans as determined by the Eagles in its sole discretion from all eligible entries (x) for online, received on or prior to 11:59 p.m. Eastern Time on the Tuesday immediately prior to the home playoff game for each respective Entry Period (y) for mail-in entries, received on or prior to 2:59 p.m. Eastern Time on the Wednesday immediately prior to the home playoff game for each respective Entry Period. Non-winning entries from prior Entry Periods will automatically be eligible to win a prize during a subsequent Entry Period. Each Winner will be notified by e-mail, telephone, overnight carrier or regular mail within approximately twenty-four (24) hours of the selection. If, after two (2) attempts, contact has not been made, any potential prize will be forfeited, and an alternate winner will be selected from the eligible entries received during the Entry Period. Fulfillment agent must speak with potential winner.

multiple entries are received, only the first entry will be entered into the Contest, and all other entries will be disregarded. \*If necessary – winner will only be selected if Eagles hosts a home playoff game for the applicable Entry Period.

#### 5. Prize/Odds

In accordance with these Official Rules, the following prize will be awarded to each Winner: **two (2) tickets to an Eagles Home Playoff Game during the 2022 NFL Playoffs and two (2) pregame sideline passes to such Eagles Home Playoff Game (approximate retail value: \$500)**. Parent or legal guardian must accompany the child to the applicable Eagles Home Playoff Game (i.e. one ticket will be used by the child and the other ticket will be used by the parent or legal guardian). Travel and accommodations and any other cost associated with attendance at the Eagles Home Playoff Game shall be the sole responsibility of the Winner. Limit one prize per person per Contest Period. **Odds of winning will be determined by the total number of eligible entries received during the Contest Period as well as the content of the entrant's photograph.** No assignment, transfer or substitution of prize is permitted except by the Eagles in the event of prize unavailability. Taxes on or connected with the prize and the reporting consequences thereof are the sole and exclusive responsibility of Winner and/or the Winner's parent or legal guardian.
