

2026 NEW ERA SIDELINE FAN OF THE GAME SWEEPSTAKES
OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED OR RESTRICTED BY LAW.

1. Eligibility

The 2026 New Era Sideline Fan of the Game Sweepstakes (“Sweepstakes”) is offered only in the United States to legal residents of Pennsylvania, New Jersey and Delaware who are twenty-one (21) years of age or older as of the date of entry. Employees, officers, directors, agents and representatives of New Era Cap, LLC (“New Era”) and Philadelphia Eagles, LLC (“Eagles”) and any of their agencies, owners, subsidiaries and affiliates, advertising and promotion agencies, wholesale distributors, and individual retail licensees or the immediate family (spouse, mother, father, sister, brother, daughter, son, grandson or granddaughter, regardless of where they live) or members of their same households (whether related or not) of each such individuals are not eligible to participate or win a prize. By entering, you agree to these official rules (“Official Rules”) and the decisions of the Eagles (the judging organization), which are final and binding in all respects.

2. Sweepstakes Period

Sweepstakes period begins on Monday, August 24, 2026 at 6:00:00 p.m. Eastern Time (“ET”) and ends on the date set forth in the Drawing and Home Game Chart in Section 4 of these Official Rules and no later than Monday, November 30, 2026 at 11:59:59 p.m. ET (the “Sweepstakes Period”). There will be three (3) entry periods (each, an “Entry Period”) during the Sweepstakes Period as set forth in the chart below, and one (1) winner will be selected following the conclusion of each Entry Period. The Eagles’ computer shall be the official clock of the Sweepstakes.

3. Entry

You may enter by going to <https://forms.philadelphiaeagles.com/f/newerasweeps>, clicking on the icon to access the entry form during an Entry Period during the Sweepstakes Period and entering your date of birth and country of residence, and then entering your name, zip code, and e-mail address, and confirming that you have read and agree to the Official Rules. Upon completing the entry method, and subject to the conditions below, you will automatically be entered into the Sweepstakes. Each Entry Period begins and ends at the specific times and dates set forth in the Drawing and Home Game Chart in Section 4 of these Official Rules. Proof of entry submission does not equate to proof of receipt. Entrants agree to be bound by the Official Rules.

4. Drawing

Three (3) drawings in total will be conducted by the Eagles and held on or about the dates set forth in the chart below. One (1) winner per drawing will be selected randomly by the Eagles from all eligible entries received during each Entry Period, for a maximum of three (3) potential winners. Non-selected entries will not carry forward to subsequent drawings. Winner of each drawing will be notified by e-mail within approximately two (2) days of the drawing. If, after two (2) attempts, contact has not been made, prize will be forfeited and an alternate winner may be randomly selected from the eligible entries received during the applicable Entry Period. Final designation as a winner depends on verification of eligibility as determined by Eagles. Winners may not substitute or redeem prizes for cash, but the Eagles reserves the right to substitute prize with a prize of equal or greater value should the advertised prize become unavailable for any reason.

Number of drawings and drawing dates are subject to change, at Eagles' sole discretion. If a participating Philadelphia Eagles home game is cancelled or inaccessible to fans for any reason, the drawing following such home game shall be cancelled and removed from the list of drawings above. Entries must be received by the end of each Entry Period.

5. Prize/Odds

One (1) winner will be awarded the following prize at the conclusion of Entry Period #2: two (2) tickets to the Philadelphia Eagles vs. Carolina Panthers game scheduled to take place at Lincoln Financial Field on Sunday, October 18, 2026 (ARV \$1,000), one (1) parking pass (ARV \$45) and (2) pre-game sideline passes (ARV \$500) (total ARV \$1,545). One (1) winner will be awarded the following prize at the conclusion of Entry Period #3: two (2) tickets to the Philadelphia Eagles vs. Indianapolis Colts game scheduled to take place at Lincoln Financial Field on Sunday, December 13, 2026 (ARV \$1,000), one (1) parking pass (ARV \$45) and (2) pre-game sideline passes (ARV \$500) (total ARV \$1,545). Seat locations to be determined by Eagles in its sole discretion. If winner's guest is a minor, winner must be the parent or legal guardian of such guest.
