

## **DIETZ & WATSON MEAT THE ROOKIES SWEEPSTAKES OFFICIAL RULES**

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED OR RESTRICTED BY LAW.**

### **1. Eligibility**

Sweepstakes is offered only in the United States to legal residents of Delaware, New Jersey, and Pennsylvania who are eighteen (18) years of age or older, as of the date of entry. Employees, officers, directors, agents and representatives of Philadelphia Eagles, LLC (the “Eagles”), Dietz & Watson, Inc. (“Dietz & Watson” or “Sponsor”) and any of their respective agencies, owners, subsidiaries and affiliates, advertising and promotion agencies, wholesale distributors, and individual retail licensees or the immediate family (spouse, mother, father, sister, brother, daughter, son, grandson or granddaughter, regardless of where they live) or members of their same households (whether related or not) of each such individuals are not eligible to participate or win a prize. Sweepstakes period begins on April 25, 2024 at 12:00:00 p.m. Eastern Time (“ET”) and ends on May 24, 2024 at 11:59:59 p.m. ET (the “Sweepstakes Period”). There will be one (1) drawing following the conclusion of the Sweepstakes Period.

### **3. Entry**

You may enter by going to <https://forms.philadelphiaeagles.com/f/dietzsweeps>, clicking on the icon to access the entry form during the Sweepstakes Period and entering your first name, last name, address, zip code, e-mail address (no P.O. Boxes accepted), and confirming that you are eighteen (18) years of age or older and agree to the Official Rules. Upon completing the entry method, and subject to the conditions below, you will automatically be entered into the Sweepstakes. Proof of entry submission does not equate to proof of receipt. Entrants agree to be bound by the Official Rules.

#### **4. Drawing**

One (1) drawing in total will be conducted by the Eagles following the conclusion of the Sweepstakes Period and held on or about May 27, 2024. One (1) winner will be selected randomly by the Eagles from all eligible entries received during the Sweepstakes Period. Winner of the drawing will be notified by e-mail within approximately one (1) day of the drawing. If, after two (2) attempts, contact has not been made, prize will be forfeited, and an alternate winner may be randomly selected from the eligible entries received during the Sweepstakes Period. Fulfillment agent must speak with potential winner. Final designation as the winner depends on verification of eligibility as determined by Sponsor.

#### **5. Prize/Odds**

In accordance with these Official Rules, one (1) winner will be awarded the following prize: four (4) tickets (ARV \$200) and four (4) sideline passes (ARV \$260) to a home game in which the Eagles play during the 2024 NFL pre-season at Lincoln Financial Field (the "Event") and an autographed authentic Eagles helmet (ARV \$190). Total ARV \$650. Player autograph and Eagles pre-season home game and seat locations to be determined by Eagles in its sole discretion.

**Odds of winning will be determined by the total number of eligible entries received during the Sweepstakes Period.** No assignment, transfer or substitution of prize is permitted except by the Eagles in the event of prize unavailability.
