

EAGLES SEASON TICKET MEMBER SUPER FAN CONTEST OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED OR RESTRICTED BY LAW.

1. Eligibility

Contest is offered only in the United States to legal residents of the fifty (50) United States and the District of Columbia (excluding New York, Florida, and Rhode Island) who are twenty-one (21) years of age or older (or the age of majority in their jurisdiction of residence, whichever is older), as of the date of entry. Employees, officers, directors, agents and representatives of Philadelphia Eagles, LLC (the "Eagles") and any of its agencies, owners, subsidiaries and affiliates, or the immediate family (spouse, mother, father, sister, brother, daughter, son, grandson or granddaughter, regardless of where they live) or members of their same households (whether related or not) of each such individuals are not eligible to win a prize. By entering, you agree to these Official Rules and the decisions of the Eagles (the judging organization), which are final and binding in all respects.

2. Contest Period

Contest period begins on Friday, August 21, 2026 at 10:00:00 a.m. Eastern Time and ends on Monday, October 12, 2026 at 12:00:00 p.m. Eastern Time (the "Contest Period"). The Eagles' computer shall be the official clock of the Contest. There will be one (1) winner selected during the Contest Period.

3. Entry

You may enter by going to [<https://forms.philadelphiaeagles.com/f/stmsuperfan>], clicking on the icon to access the entry form during the Contest Period and entering your date of birth and country of residence, and then entering your first name, last name, zip code, e-mail address, name of the Eagles season ticket member that you are nominating ("Nominated Season Ticket Member"), account number of the Nominated Season Ticket Member (if known), seat location of Nominated Season Ticket Member (if known), phone number of Nominated Season Ticket Member, e-mail address of Nominated Season Ticket Member, and confirm that you have read and agree to the Official Rules. Next, in 500 words or less for each response, answer the following questions:

- (1) Describe what the Nominated Season Ticket Member's lasting legacy will be as a Philadelphia Eagles fan.
- (2) Explain how the Nominated Season Ticket Member has had a positive influence in their local community.
- (3) Explain why the Nominated Season Ticket Member deserves to be the Eagles Season Ticket Member Super Fan.

Subject to the conditions below, the Nominated Season Ticket Member will automatically be entered into the Contest. Each Nominated Season Ticket Member must be a current Eagles Season Ticket Member in Good Standing (as defined below) to be eligible for entry. Proof of

entry submission does not equate to proof of receipt. Entrants agree to be bound by the Official Rules.

LIMIT ONE (1) ENTRY NOMINATION PER SEASON TICKET MEMBER DURING CONTEST PERIOD. If multiple entries are received, only the first entry will be entered into the contest, and all other entries will be disregarded. The potential winners may be required to show proof that they are a Season Ticket Member in Good Standing. "Good Standing" shall mean that, as of the date of registration, the entrant does not have any outstanding payments owed to the Eagles or Eagles Stadium Operator, LLC with respect to tickets or hospitality at Lincoln Financial Field (the "Stadium").

No responsibility is assumed for lost, late, incomplete, stolen, misdirected or illegible entry or for any computer, telephone, cable, network, satellite, electronic or Internet hardware or software malfunctions, failures, connections, availability or garbled or jumbled transmissions, or service provider/Internet/Web site/use net accessibility or availability, traffic congestion, or unauthorized human intervention. No mass entries or mechanically reproduced entries will be accepted. All entries become the exclusive property of the Eagles and will not be returned or acknowledged. Any attempts by an individual to access the website via a bot script or other brute-force attack will result in that IP address becoming ineligible. The Eagles will prosecute any fraudulent activities to the fullest extent of the law. The Eagles reserves the right to suspend or terminate this contest without notice if it determines, in its sole discretion, that the contest becomes infected or otherwise corrupted.

4. Winner

One (1) Nominated Season Ticket Member will be selected as the winner (the "Winner") based on the essays submitted that express why the Nominated Season Ticket Member is most deserving of being the Eagles Season Ticket Member Super Fan, as determined by the Eagles in its sole discretion. The Winner will be selected on or about Tuesday, October 13, 2026 from all eligible entries received during the Contest Period. The Winner will be notified by email, telephone, overnight carrier or regular mail within approximately twenty-four (24) hours of the selection. If, after two (2) attempts, contact has not been made, any potential prize will be forfeited and an alternate winner will be selected from the eligible entries received during the Contest Period. Fulfillment agent must speak with potential winner. The party nominating the Nominated Season Ticket Member (the "Nominator") is not eligible for or entitled to any prize. A winning Nominated Season Ticket Member receives the entire benefit of the Prize.

5. Prize/Odds

In accordance with these Official Rules, the Winner will receive a trip for the Winner and one (1) guest (both aged twenty-one (21) or over) to Super Bowl LXI scheduled to take place in Inglewood, California. The trip will include round trip coach-class airfare for Winner and one (1) guest from a major airport nearest Winner's residence, as determined by Eagles in its sole discretion, to Inglewood, California, two (2) nights standard hotel accommodation (single room, double occupancy, room and tax only) at a hotel to be selected by Eagles, round trip ground transportation to and from the airport (or, in the event Winner lives within 100 miles from Inglewood, California, to and from the hotel), and two (2) game tickets to Super Bowl LXI scheduled to take place in Inglewood, California on February 14, 2027. In addition, the Winner

will receive access to two (2) exclusive virtual events hosted by the National Football League scheduled to take place between December 2026 and February 2027 (“NFL”) (collectively, the “Prize”). The total approximate retail value (“ARV”) for the Prize is **\$5,000**.

The actual value of the Prize depends on the city of departure and fluctuations in airfare. Any difference between the actual value of a Prize and the stated ARV (if less than the actual value) will not be awarded. **Travel must be taken between February 13 and February 15, 2026 (or as otherwise determined by Eagles in its sole discretion) or the Prize will be forfeited, and Eagles will have no further obligation to such Winner.** Winner is responsible for any transportation not specifically noted in these Official Rules. Airline tickets and travel are subject to terms and conditions set forth in these Official Rules and those set forth by selected travel providers.

Winner and guest must travel together and on the same itinerary and are responsible for obtaining all necessary travel documents, including government-issued photo identification required for air travel prior to travel. Winner is solely responsible for the associated costs for any necessary travel documents. Certain restrictions, as determined by Eagles, may apply. Eagles will attempt to accommodate Winner’s preferred itinerary, but all specifics thereof will be at Eagles’ discretion. Eagles are not responsible for any fees or additional charges resulting from Winner’s change(s) to itinerary or accommodations. If Winner and guest cannot travel on the dates specified by Eagles, cannot comply with these restrictions or any other portion of these Official Rules, the Prize will be forfeited in its entirety and an alternate winner may be chosen, if time permits. Winner and guest must travel from a major airport near the Winner’s residence, as determined by Eagles, in its sole discretion. In the event a Winner lives within 100 miles from Inglewood, California, ground transportation only (in lieu of air transportation) will be provided to and from the hotel, in Eagles’ sole discretion. Travel arrangements must be made through Eagles’ agent, on a carrier of Eagles’ choice, and trip must be taken on the dates of the Eagles’ choosing and surrounding the events. Flight details are subject to availability, and airline carrier’s regulations and conditions apply. The trip may not be combined with any other offer, and travel will not qualify for frequent flyer miles. The Released Parties (as defined below) are not responsible for lost or mutilated tickets, and none will be replaced. The Released Parties are not responsible for any cancellations, delays, diversions or substitution or any act or omissions whatsoever by any air carrier, hotel, or other transportation company or any other person providing any of these services and accommodations. The Released Parties shall not be liable for any loss or damage to baggage. Airline tickets are non-refundable, non-transferable, and are not valid for upgrades. The hotel accommodations, airline tickets and ground transportation will be determined at the sole discretion of Eagles.

The date and time of Super Bowl LXI are subject to change. Eagles is not liable if Super Bowl LXI is postponed, canceled, or otherwise changed. Tickets are subject to terms and conditions stated thereon or on the Super Bowl LXI website as well as venue restrictions and are NOT for re-sale. For the avoidance of doubt, unused tickets cannot be refunded, exchanged, or applied toward tickets for any subsequent game or for cash. Eagles makes no guarantee as to the location of the seats for the game and exact seats will be determined by NFL in its sole discretion. Winner and guest must comply with all stadium rules and regulations, including, without limitation, all health and safety protocols, and ticket terms and conditions at all times.

Commented [RW1]: Note to Gabrielle: We’ve used this \$5,000 amount for ARV as a placeholder only. Understanding the value of the 2 tickets is \$500, we’d ask you to double check the approximate retail values of the airfare (for 2)—generally knowing that it will fluctuate depending on location, hotel accommodations for 2 nights, round trip ground transportation to/from airport for 2 and the 2 virtual events. The latter, even though virtual, should have some value assigned to them by the league to quantify the experience. Once we have the information, we can update the ARV as needed.

Commented [RW2]: Note to Gabrielle: In the 2025 NFL Fan of the Year Contest, the winners received 4 nights stay at a hotel. Typically, for these types of trips, we see at least 2 nights stay to avoid having winner/guest travel on the day of the game. I know we originally discussed 1 night stay at a hotel, but we’d suggest lengthening to 2 (if possible) to avoid issues with travel delays, cancelled flights, etc.

Failure to do so may result in forfeiture of the Prize. The terms and conditions of the tickets awarded will govern in the event a game, as defined by Eagles, is not played due to any reason, including, without limitation, weather, an act of God, an act of terrorism, a war or war-like action, a public health emergency, or civil disturbance. Eagles and/or NFL reserves the right, in their sole discretion, to remove or to deny entry to Winner and/or guest if such individual engages in a non-sportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten, or harass any other person at the game. If any portion of the Prize is not available for any reason, then Eagles reserves the right to substitute that portion of the Prize with another prize of comparable or greater value. Guest must complete a Travel Companion Affidavit and a Waiver and Liability Release and submit it to Eagles before the Prize is awarded.
