# 2023 EAGLES NFL DRAFT PARTY BADGE COLLECTION SWEEPSTAKES – OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED OR RESTRICTED BY LAW.

## 1. Eligibility

Sweepstakes is offered only in the United States to legal residents of Pennsylvania, New Jersey and Delaware who are eighteen (18) years of age or older (or the age of majority in their jurisdiction of residence, whichever is older) as of the date of entry and attend the Eagles NFL Draft Party scheduled to take place at Lincoln Financial Field on Thursday, April 27, 2023. Employees, officers, directors, agents and representatives of Philadelphia Eagles, LLC ("Eagles") and any of their respective agencies, owners, subsidiaries and affiliates, advertising and promotion agencies, wholesale distributors, and individual retail licensees or the immediate family (spouse, mother, father, sister, brother, daughter, son, grandson or granddaughter, regardless of where they live) or members of their same households (whether related or not) of each such individuals are not eligible to participate or win a prize. By entering, you agree to these Official Rules and the decisions of the Eagles (the judging organization), which are final and binding in all respects.

## 2. Sweepstakes Period

Sweepstakes period begins on April 27, 2023 at the time the Eagles NFL Draft Party ("Draft Party") scheduled to take place at Lincoln Financial Field begins and no earlier than 6:30 p.m. Eastern Time ("ET") and ends on April 27, 2023 at 10:00 p.m. ET (the "Sweepstakes Period").

### 3. Entry

To enter, you must have downloaded the Official Eagles App and set up an Eagles OnePass account. If you do not have the Official Eagles App downloaded, visit the app store on your iOS phone or android phone and download the free Official Eagles App. To set up an Eagles OnePass account, within the Official Eagles App, log in to your profile. Within your profile, click on the Eagles OnePass icon, which will prompt you to add additional information, including your mobile phone number, zip code and date of birth, and then confirm that you agree to the Official Rules. During the Sweepstakes Period, there will be a QR code located at various locations in the Tork Club and on the playing field at Lincoln Financial Field. Entrants must scan the QR code one (1) time with the FanScan scanner located within Eagles OnePass. Upon scanning the QR code, an entrant, subject to the conditions below, will automatically be entered into the Sweepstakes. The Eagles' computer shall be the official clock of the Sweepstakes. Entrants agree to be bound by the Official Rules.

SUBJECT TO THE CONDITIONS SET FORTH BELOW REGARDING BADGE SCANNING, LIMIT ONE ENTRY PER PERSON DURING SWEEPSTAKES PERIOD (REGARDLESS OF WHETHER MORE THAN ONE PERSON USES THE SAME E-MAIL ACCOUNT). If more than one entry is submitted, only the first entry will be entered into the Sweepstakes and all other entries will be disregarded. In the event of a dispute as to any entry, the authorized account holder of the e-mail address used to enter will be deemed to be the entrant. The "authorized account holder" is the natural person assigned to the e-mail account. The potential winner(s) may be required to show proof of being the authorized account holder.

be disqualified. Automated entries (including but not limited to any entries submitted using any robot, script, macro or other automated service) are not permitted and will be disqualified.

No mass entries or mechanically reproduced entries will be accepted. All entries become the exclusive property of the Eagles and will not be returned or acknowledged. Any attempts by an individual to access the Sweepstakes via a bot script or other brute-force attack will result in that IP address becoming ineligible. The Eagles will prosecute any fraudulent activities to the fullest extent of the law. The Eagles reserves the right to suspend or terminate this Sweepstakes without notice if, in the Eagles sole discretion, the Sweepstakes becomes infected or otherwise corrupted.

### 4. Winner

There will be ten (10) winners selected randomly by the Eagles from all eligible entries received during the Sweepstakes Period as set forth below. The potential winners will be notified by the Eagles by e-mail or text message within approximately two (2) business days. Return of any notification as undeliverable or if the potential winner does not claim prize within twenty-four (24) hours, the prize will be forfeited in its entirety and an alternate winner may be selected. Final designation as the winner depends on verification of eligibility as determined by Eagles. Winner may not substitute or redeem prize for cash, but the Eagles reserves the right to substitute prize with a prize of equal or greater value should the advertised prize become unavailable for any reason.

# 5. Prize/Odds

In accordance with these Official Rules, five (5) winners will each win one (1) autographed mini helmet (approximate retail value \$30); three (3) winners will each win one (1) autographed panel replica football (approximate retail value \$50); one (1) winner will win one (1) autographed replica helmet (approximate retail value \$100); and one (1) winner will win two (2) tickets a home game in which the Eagles play during the 2023 NFL season scheduled to take place at Lincoln Financial Field (approximate retail value \$300). Player autographs, the home game selection and seat locations to be determined in Eagles sole discretion.

Odds of winning will be determined by the total number of badges scanned by each entrant and eligible entries received during the Sweepstakes Period. Entrants who scan one (1) or more badges will be eligible to win a mini helmet; entrants who scan two (2) or more badges will be eligible to win an autographed panel replica football; entrants who scan three (3) or more badges will be eligible to win an autographed replica helmet; and entrants who scan four (4) or more badges will be eligible to win tickets to a home game in which the Eagles play during the 2023 NFL season scheduled to take place at Lincoln Financial Field. Entrants may be eligible to win more than one type of prize depending on the number of badges scanned, but entrants can win only one prize.
