

2025 DRONE SHOW SWEEPSTAKES – OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED OR RESTRICTED BY LAW.

1. Eligibility

The 2025 Drone Show Sweepstakes (“Sweepstakes”) is offered only in the United States to legal residents of Pennsylvania, New Jersey, Delaware and Maryland who are twenty-one (21) years of age or older as of the date of entry. Employees, officers, directors, agents and representatives of Philadelphia Eagles, LLC (“Eagles”) and any of its agencies, owners, subsidiaries and affiliates, advertising and promotion agencies, wholesale distributors, and individual retail licensees or the immediate family (spouse, mother, father, sister, brother, daughter, son, grandson or granddaughter, regardless of where they live) or members of their same households (whether related or not) of each such individuals are not eligible to participate or win a prize. By entering, you agree to these Official Rules and the decisions of the Eagles (the judging organization), which are final and binding in all respects.

2. Sweepstakes Period

Sweepstakes period begins on Saturday, January 25, 2025 at 6:00 p.m. Eastern Time (“ET”) and ends on Sunday, January 26, 2025 at 7:59:00 a.m. ET (the “Sweepstakes Period”). The Eagles’ computer shall be the official clock of the Sweepstakes.

3. Entry

During the Sweepstakes Period, you may enter by scanning the QR code formed by drones at the Eagles drone show or on signs posted in and around the show scheduled to take place outside the Philadelphia Museum of Art on Saturday, January 25, 2025 at approximately 6:00 p.m. ET (the “Drone Show”). Upon scanning the QR code, an entrant will be taken to <https://forms.philadelphiaeagles.com/f/2025DroneShowSweepstakes>, where they can enter the Sweepstakes by completing the entry form and entering date of birth and country of residence and then first name, last name, e-mail address, zip code and phone number, and confirming that they agree to the Official Rules. Upon completing the entry method, and subject to the conditions below, you will automatically be entered into the Sweepstakes. Attendance at the Drone Show is not required to enter the Sweepstakes. Proof of entry submission does not equate to proof of receipt. Entrants agree to be bound by the Official Rules.

LIMIT ONE ENTRY PER PERSON DURING SWEEPSTAKES PERIOD (REGARDLESS OF WHETHER MORE THAN ONE PERSON USES THE SAME E-MAIL ACCOUNT). If more than one entry is submitted, only the first entry will be entered into the Sweepstakes and all other entries will be disregarded. In the event of a dispute as to any entry, the authorized account holder of the e-mail address used to enter will be deemed to be the entrant. The “authorized account holder” is the natural person assigned an e-mail address by an Internet access provider, online service provider or other organization responsible for assigning e-mail addresses for the domain associated with the submitted address. The potential winner may be required to show proof of being the authorized account holder.

Any attempt by any person to submit more than the stated number of entries by using multiple/different accounts or any other methods will void that person’s entry and that person will be disqualified. Automated entries (including but not limited to any entries submitted using any robot, script, macro or other automated service) are not permitted and will be disqualified.

No responsibility is assumed for lost, late, incomplete, stolen, misdirected or illegible entry; or for any computer, telephone, cable, network, satellite, electronic or Internet hardware or software malfunctions, failures, connections, availability or garbled or jumbled transmissions, or service provider/Internet/Web site/use net accessibility or availability, traffic congestion, or unauthorized human intervention. No mass entries or mechanically reproduced entries will be accepted. All entries become the exclusive property of the Eagles and will not be returned or acknowledged. Any attempts by an individual to access the Sweepstakes via a bot script or other brute-force attack will result in that IP address becoming ineligible. The Eagles will prosecute any fraudulent activities to the fullest extent of the law. The Eagles reserves the right to suspend or terminate this Sweepstakes without notice if, in the Eagles sole discretion, the Sweepstakes becomes infected or otherwise corrupted.

4. Winner

One (1) drawing in total will be conducted by the Eagles following the conclusion of the Sweepstakes Period and held on January 26, 2025. One (1) winner will be selected randomly by the Eagles from all eligible entries received during the Sweepstakes Period. Winner of the drawing will be notified by text, e-mail or phone within approximately one (1) hour of the drawing. If, after two (2) attempts over one (1) hour, contact has not been made, prize will be forfeited and an alternate winner may be randomly selected from the eligible entries received during the Sweepstakes Period. Final designation as the winner depends on verification of eligibility as determined by Eagles. Winner may not substitute or redeem prize for cash, but the Eagles reserves the right to substitute prize with a prize of equal or greater value should the advertised prize become unavailable for any reason.

5. Prize/Odds

In accordance with these Official Rules, one (1) winner will be awarded the following prize: Two (2) tickets to the NFC Championship Game between the Philadelphia Eagles and Washington Commanders scheduled to take place at Lincoln Financial Field on Sunday, January 26, 2025 (the "Game") (approximate retail value \$920). Seat location for game to be determined by Eagles in its sole discretion.

Odds of winning will be determined by the total number of eligible entries received during the Sweepstakes Period. No assignment, transfer or substitution of prize is permitted except by the Eagles in the event of prize unavailability. Travel expenses and any other costs associated with attendance at the Game shall be the sole responsibility of winner. If the winner's guest to the Game is a minor, the winner must be the parent or legal guardian of such guest. Taxes on or connected with the prize and the reporting consequences thereof are the sole and exclusive responsibility of winner.

6. General Conditions
