

2026 NOURYON ALL-PRO TEACHERS PROMOTION OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED OR RESTRICTED BY LAW.

1. Eligibility

This promotion will begin Wednesday July 1, 2026 at 3:00:00 PM Eastern Time (“ET”) and end on Thursday, October 29, 2026 at 11:59:59 PM ET (the “Promotional Period”). To be entered into the promotion, a person must be officially nominated as set forth below. Nominees must currently be employed as teachers by a school located in Pennsylvania, Delaware, or New Jersey (and within 75 miles of Lincoln Financial Field located at 1 Lincoln Financial Field Way, Philadelphia, PA 19148) and must teach any grade level between 5th grade and 12th grade. Previous All-Pro Teacher winners are not eligible to be nominated or win. Nominators must be 18 years of age or older and U.S. residents of Pennsylvania, Delaware or New Jersey. Employees, officers, directors, agents, and representatives of Philadelphia Eagles, LLC (the “Eagles”), Nouryon Chemicals LLC (“Nouryon”), and any of their agencies, owners, subsidiaries, and affiliates, or the immediate family (spouse, mother, father, sister, brother, daughter, son, grandson, or granddaughter, regardless of where they live) or members of their same households (whether related or not) of each such individual are not eligible to Nominate or win a prize. By nominating a teacher, you agree to these Official Rules and the decisions of the Eagles and Nouryon (the judging organizations), which are final and binding in all respects.

2. Nominations

To nominate a Nouryon All-Pro Teacher go to the Official Website, www.philadelphiaeagles.com/community/allproteachers/ during the Promotional Period and complete the following information:

- Enter your name, email address, primary phone number, and your relationship to the Nominee (current/former student, current/former principal, or co-worker).
- Enter the Nominee’s name, email address and phone number, the name of the school where the Nominee teaches, the status of the school, the grade that the Nominee teaches, and the state where the school is located.
- Explain your nomination by answering the questions in the space provided (500 words or less per question).
- Affirm that you are 18 years of age or older and agree to the Official Rules.
- If the nomination is missing required information, it will be considered invalid.

Definition of a Nouryon All-Pro Teacher is someone who:

- *Uses creative out-of-the-box teaching methods to inspire student ingenuity*
- *Bases projects on real-world examples*
- *Empowers students to bring their ideas to life in tangible ways*
- *Is a role model for their students in and out of the classroom*
- *Develops critical thinking skills and tolerance for diverse perspectives that drive success in all academic subjects*
- *Challenges and engages students through a unique and collaborative curriculum*
- *Is a steward of new ideas of academics and helps to foster creative thinking*

- *Has passion for their work and brings it out in their students*
- *Encourages their students to pursue their own personal curiosity*

Using the definition above, describe how your Nominee exemplifies what it means to be a Nouryon All-Pro Teacher.

- Give specific details and examples of how your nominee brings education to life in a unique, engaging, and innovative way.
- Describe an instance or instances when your nominee influenced a student to pursue their passion for learning (name projects, mentorships, etc.).

LIMIT ONE NOMINATION PER NOMINATOR DURING THE PROMOTIONAL PERIOD. If multiple nominations are received during any selection period, only the first nomination will be entered into the promotion and all other nominations will be disregarded. Nominations will only be accepted from persons who are currently or were formerly a student of the nominee, a current or former principal at the nominee's school while the nominee was employed there, or a co-worker of the nominee who worked in a teaching capacity while employed by the same school as the nominee. Any person who has previously been named an All-Pro Teacher is not eligible to be nominated or to win. An individual cannot nominate himself or herself.

Nominations that are late, incomplete, inaccurate, illegible, lost, or damaged are void as determined by and in the sole and absolute discretion of the Eagles and Nouryon. All nominations received after the Promotional Period closes may be held by the Eagles and Nouryon. In the event that the Eagles and Nouryon, in their sole discretion, choose to run a similar promotion in any future year, such held nominations may be entered automatically into the future promotion ("Prior Entries"), subject to approval by the Eagles and Nouryon. By entering, entrants acknowledge compliance with the rules and regulations, including all eligibility requirements. Nominations become the property of the Eagles and Nouryon and will not be acknowledged or returned. Eagles and Nouryon reserve the right to verify any information received as part of a Nomination. None of the Eagles, Nouryon, nor any of their respective officers, directors, shareholders, employees, or agents are responsible for incorrect or inaccurate transcription of nomination information. Nomination materials that have been tampered with or altered are void. The Eagles and Nouryon reserve the right in their sole and absolute discretion to cancel, modify, or suspend the promotion should technical or other occurrences beyond their control compromise the administration, security, or proper play of the promotion.

3. Determination of Winners

Winners will be selected by the Eagles and Nouryon, in their sole discretion based on satisfaction of the criteria set forth in Section 2, in the manner described below. In no event will more than one teacher from the same school be selected as a winner during the same Promotional Period.

Ten (10) winners will be selected as Nouryon All-Pro Teachers by Eagles and Nouryon from any Prior Entries and all eligible nominations received during the Promotional Period prior to the selection date. These winners will be selected as follows: three (3) on July 23, 2026; three (3) on September 3, 2026; four (4) on October 22, 2026. One (1) grand prize winner will be selected from the group of ten winners and named the Nouryon All-Pro Teacher of the Year on or before April 1, 2027. Announcement of the grand prize winner will not be made until the Nouryon All-Pro Teacher Award Ceremony, held at a later date.

Odds of winning the promotion depend upon the number of eligible Nominations received between the opening and closing of the promotion and the performance criteria of the Nominee. If not selected, nominees are eligible for potential subsequent promotions. Winners will be notified via email or phone during the week of their selection. Winners may be required to complete, sign, and return an affidavit of eligibility (which includes proof of active employment as a teacher at the school of record during the Promotional Period) and liability/publicity release (where legal) which must be completed and returned within three (3) days of issuance of notification. If the Eagles and Nouryon do not receive such documents properly signed within three (3) days of issuance, prize may be forfeited in the sole and absolute decision of the Eagles and Nouryon and an alternate winner may be selected. Prizes are not transferable and may not be redeemed for cash or other considerations. In accordance with these Official Rules, the following prizes will be awarded to **each Nouryon All-Pro Teacher winner**: four (4) tickets and one (1) parking pass for one (1) Philadelphia Eagles home game during the 2026 NFL season scheduled to be played at Lincoln Financial Field (the exact location of the tickets and the exact date and time of the game will be determined by Eagles in its sole discretion); four (4) admission tickets to the Nouryon All-Pro Teacher Award Ceremony (the exact date, time and location of which will be determined by Eagles and Nouryon in their sole discretion; ceremony may be virtual); one (1) personalized replica Eagles jersey; and one (1) personalized Eagles football (Approximate retail value of each prize: \$1,200). In addition, each nominator of a winning Nominee selected to be a Nouryon All-Pro Teacher will win one (1) \$250 Eagles Pro Shop gift card. Along with these prizes, and subject to these Official Rules, Nouryon will make a \$2,000 donation to each winner's employing school to be used exclusively for school supplies or student-related programming (if the winner has changed schools, the school by which the winner was employed at the time of the nomination will receive the donation). Prior to receiving a donation, the school must submit a current Form W-9 and a detailed, budgeted summary of what the funds will be used for to be approved by the Eagles and Nouryon in their sole discretion. If such documents are not received within thirty (30) days of notification of issuance, prize may be forfeited in the sole and absolute discretion of the Eagles and Nouryon and an alternate winner may be selected. Check will be sent to the location provided on the Form W-9. Winner is responsible for all travel and other expenses to the selected Eagles home football game, and any other aspects of the prizes.

In lieu of a Pep Rally, Eagles may choose a different type of event, virtual or in-person, in its sole discretion. Additionally, Nouryon will make a \$5,000 donation to the grand prize winner's employing school to be used exclusively for school supplies or student-related programming (if the winner has changed schools, the school by which the winner was employed at the time of the nomination will receive the donation). Prior to receiving the donation, the school must submit a current Form W-9 and a detailed, budgeted summary of what the funds will be used for to be approved by the Eagles and Nouryon in their sole discretion. If such documents are not received within thirty (30) days of

notification of issuance, prize may be forfeited in the sole and absolute discretion of the Eagles and Nouryon and an alternate winner may be selected. Check will be sent to the location provided on the Form W-9.
