

2025 EAGLES LANDING SWEEPSTAKES – OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED OR RESTRICTED BY LAW.

1. Eligibility

The 2025 Eagles Landing Sweepstakes (“Sweepstakes”) is offered only in the United States to legal residents of the fifty (50) United States and the District of Columbia, except New York, Florida and Rhode Island, who are eighteen (18) years of age or older (or the age of majority in the jurisdiction in which they reside, whichever is older) as of the date of entry. Employees, officers, directors, agents and representatives of Philadelphia Eagles, LLC (“Eagles”) and any of its agencies, owners, subsidiaries and affiliates, advertising and promotion agencies, wholesale distributors, and individual retail licensees or the immediate family (spouse, mother, father, sister, brother, daughter, son, grandson or granddaughter, regardless of where they live) or members of their same households (whether related or not) of each such individuals are not eligible to participate or win a prize. By entering, you agree to these Official Rules and the decisions of the Eagles (the judging organization), which are final and binding in all respects.

2. Sweepstakes Period

Sweepstakes period begins on Monday, December 8, 2025 at 12:00 p.m. Eastern Time (“ET”) and ends on Monday, February 9, 2026 at 5:00 p.m. ET (the “Sweepstakes Period”). The Eagles’ computer shall be the official clock of the Sweepstakes.

3. Entry

You may enter by going to <http://forms.philadelphiaeagles.com/f/2025EaglesLandingsSweepstakes>, clicking on the icon to access the entry form during the Sweepstakes Period and entering your date of birth and country of residence, and then entering your first name, last name, zip code, e-mail address, and confirm that you have read and agree to the Official Rules. Upon completing the entry method, and subject to the conditions below, you will automatically be entered into the Sweepstakes. Proof of entry submission does not equate to proof of receipt. Entrants agree to be bound by the Official Rules.

Any attempts by an individual to access the Sweepstakes via a bot script or other brute-force attack will result in that IP address becoming ineligible. The Eagles will prosecute any fraudulent activities to the fullest extent of the law. The Eagles reserves the right to suspend or terminate this Sweepstakes without notice if, in the Eagles sole discretion, the Sweepstakes becomes

infected or otherwise corrupted.

4. Winner

Following the conclusion of the Sweepstakes Period, fourteen (14) winners (one (1) Grand Prize Winner, three (3) Secondary Prize Winners and ten (10) Third Place Prize Winners) will be selected randomly by the Eagles from all eligible entries received during the Sweepstakes Period. Winners will be notified by e-mail on or about February 12, 2026. If, after two (2) attempts contact has not been made, any potential prize will be forfeited and an alternate winner may be randomly selected from the eligible entries received during the Sweepstakes Period. Final designation as a winner depends on verification of eligibility as determined by Eagles. Winners may not substitute or redeem any prize for cash, but the Eagles reserves the right to substitute any prize with a prize of equal or greater value should the advertised prize become unavailable for any reason.

5. Prize/Odds

Grand Prize: In accordance with these Official Rules, one (1) Grand Prize Winner will be awarded the following prize: one (1) autographed authentic Philadelphia Eagles jersey. Approximate retail value (“ARV”) of the grand prize is \$500). Player jersey and autograph to be determined by Eagles in its sole discretion.

Secondary Prize: In accordance with these Official Rules, three (3) Secondary Prize Winners will each be awarded the following prize: one (1) autographed authentic Philadelphia Eagles helmet. ARV of each secondary prize is \$300. Player autographs to be determined by Eagles in its sole discretion.

Third Place Prize: In accordance with these Official Rules, ten (10) Third Place Prize Winners will each be awarded the following prize: one (1) autographed Philadelphia Eagles Super Bowl LIX Championship book. ARV of each secondary prize is \$150. Player autographs to be determined by Eagles in its sole discretion.

Odds of winning will be determined by the total number of eligible entries received during the Sweepstakes Period. No assignment, transfer or substitution of any prize is permitted except by Eagles in the event of prize unavailability. Taxes on or connected with any prize and the reporting consequences thereof are the sole and exclusive responsibility of each winner.
