

## NEW YORK FOOTBALL GIANTS

### *2026 DRAFT PARTY JAXSON DART & CAMERON SKATTEBO LOOK-ALIKE CONTEST*

#### OFFICIAL CONTEST RULES

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.**

**VOID OUTSIDE OF THE UNITED STATES AND WHERE PROHIBITED OR RESTRICTED BY LAW. THE FOLLOWING PROMOTION IS INTENDED FOR VIEWING IN THE UNITED STATES ONLY AND SHALL BE CONSTRUED AND EVALUATED ACCORDING TO UNITED STATES LAW. PLEASE DO NOT PROCEED IF YOU ARE NOT LOCATED IN THE UNITED STATES.**

1. **SPONSOR OF THE 2026 DRAFT PARTY JAXSON DART & CAMERON SKATTEBO LOOK-ALIKE CONTEST** (the “Contest”). The Sponsor of the Contest is New York Football Giants LLC, whose address is 1925 Giants Drive, East Rutherford, NJ 07073.
2. **CONTEST PERIOD:** The Contest begins at 7:00 PM Eastern Time (“ET”) on April 23, 2026, and ends on April 23, 2026, once both potential winners of the Contest have been selected at the 2026 Giants Draft Party at Hudson Yards, 30 Hudson Yards, New York, NY 10001 (the “Contest Period”).
3. **RULES:** These Official Contest Rules comprise the entire set of Official Rules governing this Contest. **IF YOU ENTER THE CONTEST YOU AGREE TO THESE RULES.**
4. **ELIGIBILITY:** Contest open only to individual eligible residents of the United States who are 18 years of age or older at the time of entry, and who are in attendance at the 2026 New York Giants Draft Party at Hudson Yards, 30 Hudson Yards, New York, NY 10001 (“Hudson Yards”) on April 23, 2026 during the Contest Period.

Employees, officers, representatives and their immediate family members and household members, whether or not related, of New York Football Giants LLC (“Sponsor”), Giants Stadium LLC, New Meadowlands Stadium Company, LLC, Hudson Yards, and their respective parent companies, subsidiaries, affiliates, advertising or promotional agencies, fulfillment, marketing agencies and other third parties assisting or providing services in connection with this Contest (collectively, the “Promotion Entities”) and the NFL Entities (as defined below) are not eligible to participate. For purposes of the Contest, “immediate family members” means parents, spouses, children, and siblings, regardless of where they reside, and those living in their same households whether or not related.

Winning the prize is contingent upon fulfilling all requirements set forth in these Rules. VOID OUTSIDE OF THE UNITED STATES.

5. **HOW TO ENTER:** Entrants must attend the 2026 Giants Draft Party at Hudson Yards on April 23, 2026, and be physically present at the main stage at Hudson Yards by 7:00 PM and remain at

the event during the Contest Period.

## 6. PROHIBITED CONDUCT & ATTIRE

Entrants may **not**:

- Impersonate, or attempt to impersonate, the applicable player in a manner that is offensive, derogatory, defamatory, deceptive, fraudulent, or likely to mislead the public.
- Use the Contest to promote commercial products, political messages, or third-party services or products.
- Wear any inappropriate or indecent clothing or attire, or any clothing or attire that contains or displays any inappropriate or offensive language, text, or insignias.
- Engage in vote-buying, artificial engagement, or manipulation of any voting component of the Contest.
- Harass judges, Sponsor personnel, fans, other attendees, or other Contest entrants.
- Engage in obscene, profane, discriminatory, sexual, abusive, threatening, offensive, illegal, inappropriate, or unsafe behavior.
- Act in a manner that may harm the reputation, goodwill, or business interests of Sponsor, the NFL, or the applicable players.
- Violate any venue policies, posted rules, community standards, or applicable law, rule, or regulation.
- Infringe, misappropriate, or violate any right of any third party, including, without limitation, trademark, copyright, privacy, publicity, or other intellectual property right.

Clothing and attire should be **family-friendly** and suitable for a public event.

## 7. JUDGING CRITERIA AND SELECTION OF WINNERS:

Based on the criteria set forth below, one (1) eligible entrant will be selected as the potential Jaxson Dart look-alike winner from all eligible entrants during the Contest Period, and one (1) eligible entrant will be selected as the potential Cameron Skattebo look-alike winner from all eligible entrants during the Contest Period. Eligible entrants who are in attendance at the 2026 Giants Draft Party at Hudson Yards on April 23, 2026, at the time that the Contest is announced will be judged by a panel of two (2) influencers chosen by Sponsor based on the following skill-based criteria:

<b>Criteria</b>	<b>Weight</b>
Resemblance to the designated player	25%
Creativity and overall presentation	25%
Enthusiasm, spirit, and entertainment value	25%
Compliance with Contest theme and instructions	25%

To be eligible to win a Prize, entrants must also be physically present at the 2026 Giants Draft Party at Hudson Yards on April 23, 2026, during the entire Contest Period.

The eligible entrant who receives the highest overall score as the Jaxson Dart look-alike, and the eligible entrant who receives the highest overall score as the Cameron Skattebo look-alike, as determined by Sponsor and/or the judging panel in their sole discretion based on the criteria set forth above, will be deemed the potential winners, subject to verification of eligibility and compliance with these Official Rules.

In the event of a tie, Sponsor may apply additional judging criteria, conduct a tie-break review by one or more additional judges selected by Sponsor, or select the entrant with a higher score in any of the above four (4) categories, as determined by Sponsor.

Sponsor may disqualify any entrant at any time if Sponsor determines, in its sole discretion, that the entrant does not comply with these Official Rules or are otherwise inconsistent with Sponsor's image, reputation, or commercial interests.

Sponsor reserves the right to select alternate potential winners if an entrant is disqualified, ineligible, fails to respond in a timely manner, or fails to complete required documentation.

- (a) Odds of winning depend upon the total number of eligible entrants during the Contest Period.
- (b) Each Prize winner will be required to provide Sponsor with a complete and accurate W-9 Form and will be required to execute and return an Affidavit of Eligibility, Liability and Publicity Release within twenty-four (24) hours of the time of issuance of the notification. APPROXIMATE RETAIL VALUE: \$300.00.

All details and other restrictions of prizes not specified in these Official Rules will be determined by Sponsor in its sole discretion. Actual value of prizes may be lower or higher at the time of fulfillment, and any difference between actual value and the stated ARV (if actual value is lower than stated ARV) will not be awarded. Prize ARVs represent Sponsor's good faith determinations, are final and binding and cannot be challenged or appealed. Sponsor is not responsible if any element of a prize is delayed, postponed or cancelled for any reason. Prizes are non-transferable, non-refundable, and no substitution or cash redemption will be made except as provided herein at the Sponsor's sole discretion. Sponsor reserves the right, for whatever reason, to substitute a prize (or any component thereof) for one of equal or greater value.
