



## WAIVER OF LIABILITY AND RELEASE

The undersigned ("I," "my", "me", or "myself"), is the parent or legal guardian of the child whose name and birth date appear below ("Minor"). In return for my participation and/or allowing the Minor's participation in and attendance at activities taking place during the Enshrinement Festival and Enshrinement Week, including, but not limited to, the Pro Football Hall of Fame Play Football "First Play" Event and KidsFest, Play Football Skills Camp, Play Football Friday Clinic, and the Hall of Fame Game, to be held from Tuesday, August 4th, 2026, to Friday, August 7, 2026, at Hall of Fame Village ("HOFV"), which includes the National Football Museum, Inc. dba Pro Football of Fame ("PFHOF") in Canton, Ohio, and all related events and activities (collectively, the "Events"), I, on my own behalf and that of the Minor, WAIVE, RELEASE AND DISCHARGE from any and all liability, and agree not to sue the PFHOF, Sandlot HOFV Canton SC LLC, Canton City School District, National Football League (the "NFL"), its member professional football clubs, NFL Ventures L.P., NFL Properties LLC, NFL International LLC, NFL Enterprises LLC, NFL Productions LLC, USA Football, Inc., Heads Up Football LLC, the USA Football Foundation, Inc., and each of their respective officers, parents, affiliates, subsidiaries, successors and assigns and their respective owners, shareholders, directors, governing board, employees, subcontractors, sponsors, agents, representatives, heirs, designees and licensees (collectively, the "Program Entities"), and each operator and owner of the respective venue locations (together with the Program Entities, the "Releasees") from all present and future claims that may be made by me, the Minor, my family, estate heirs, or assigns for property damage, personal injury, or wrongful death arising as a result of my participation or the Minor's participation in the Events and related activities wherever, whenever or however the same may occur.

I understand that and agree that the Releasees are not responsible for any injury or property damage arising out of the Events, even if caused by their negligence. I understand that the Minor's participation in the Events involves certain risks, including, but not limited to, serious injury and death. I acknowledge that my participation in the Event may involve risks related to exposure to communicable diseases, viruses, bacteria or illnesses and I assume and accept all risk related to exposure to such communicable diseases, viruses, bacteria or illnesses.

On behalf of the Minor and myself, I assume all risks associated with the Minor's voluntary participation in the Events. I consent to administration of first aid and other medical treatment in the event of injury or illness to myself or the Minor. I also agree to indemnify and hold harmless the Releasees from and against any and all claims, causes of action or damages arising out of my and/or the Minor's participation in the Events and, related activities including, but not limited to, transportation to and from the Events and the administration of any first aid and/or medical treatment, and to reimburse the Releasees for any costs and expenses, including, without limitation, attorneys' fees, incurred in defending such actions.

I understand that the Events may be filmed and by signing this Waiver and attending the Events, I consent to me and the Minor being photographed, videotaped and/or recorded. I consent to such photography, videotaping and/or recording and to any use, in any and all media formats, including, without limitation, television and digital media and formats, whether now known or hereafter devised, including but not limited to any HOFV, PFHOF and/or NFL branded commercial or PSA with any HOFV, PFHOF or NFL sponsor or licensee throughout the universe in perpetuity, of my or the Minor's name, nickname, image, likeness, voice, photograph, signature facsimile, and biographical information for any purpose whatsoever, without any further action required or any consideration owing to me or the Minor from the Releasees. I understand that this Waiver is intended to be as broad and as inclusive as permitted by the laws of the state in which the Events are taking place and agree that if any portion of this Waiver is invalid, the remainder will continue in full legal force and effect. I further agree that any legal proceedings related to this Waiver will take place in Stark County, Ohio.

**FOR PARTICIPANTS AGED 18 AND OVER:** The Undersigned acknowledges and represents that the Undersigned: (1) is of legal age and is freely entering this Agreement, and intends their entering into it to be a complete and

unconditional assumption of risk, release of liability, and covenant not to sue, to the greatest extent allowed by law; **(2) has read this Agreement and understands that by entering into it, they are giving up legal rights and remedies;** (3) understands that they are responsible for determining whether attendance at and/or participation in the Activity is advisable; and (4) in entering this Agreement, have not relied on any statements or explanations by the Releasees or any of their representatives.

**FOR PARENTS OR LEGAL GUARDIANS OF PARTICIPANTS WHO ARE MINORS UNDER AGE 18:** The Undersigned acknowledges and represents that the Undersigned: (1) is the parent or legal guardian of the Minor attending and/or participating in the Activity; (2) is of legal age and is freely signing this Agreement on behalf of such Minor, and intends the Undersigned signature to be a complete and unconditional assumption of risk, release of liability, and covenant not to sue, to the greatest extent allowed by law; (3) is responsible for determining whether attendance and/or participation in the Activity is advisable for the Minor; (4) is responsible for the behavior and actions of the Minor while participating in the Activity; **(5) has read this Agreement and understands that by entering it, they are giving up legal rights and remedies on behalf of the Minor;** and (6) in entering this Agreement, they have not relied on any statements or explanations by the Releasees or any of their representatives.

READ THIS FORM COMPLETELY AND CAREFULLY. BY ALLOWING YOUR MINOR CHILD, TO ATTEND OR PARTICIPATE IN ANY ACTIVITY, YOU ARE AGREEING VOLUNTARILY TO LET YOUR MINOR CHILD, ENGAGE IN A POTENTIALLY DANGEROUS ACTIVITY. YOU ARE AGREEING THAT, EVEN IF THE RELEASED PARTIES USE REASONABLE CARE IN PROVIDING THIS ACTIVITY, THERE IS A CHANCE YOUR CHILD MAY BE SERIOUSLY INJURED OR KILLED BY PARTICIPATING IN THIS ACTIVITY BECAUSE THERE ARE CERTAIN DANGERS INHERENT IN THE ACTIVITY WHICH CANNOT BE AVOIDED OR ELIMINATED. BY SIGNING THIS FORM, OR ALLOWING YOUR MINOR CHILD, TO ATTEND OR PARTICIPATE IN ANY ACTIVITY, YOU ARE GIVING UP SUCH MINOR CHILD'S RIGHT AND YOUR RIGHT TO RECOVER FROM THE RELEASED PARTIES IN A LAWSUIT OR OTHER LEGAL PROCEEDING FOR ANY PERSONAL INJURY, INCLUDING DEATH, TO SUCH CHILD OR ANY PROPERTY DAMAGE THAT RESULTS FROM THE RISKS THAT ARE A NATURAL PART OF THE ACTIVITY. YOU HAVE THE RIGHT TO REFUSE TO AGREE TO THIS FORM, AND THE RELEASED PARTIES HAVE THE RIGHT TO REFUSE TO LET YOUR CHILD ATTEND OR PARTICIPATE IN ANY ACTIVITY IF YOU DO NOT AGREE TO THIS FORM.
