

2022 HALL OF FAME SWEEPSTAKES
OFFICIAL RULES

By entering into the 2022 Hall of Fame Sweepstakes (the “Promotion”), you agree to be bound by these Official Rules. Failure to comply with these Official Rules may result in disqualification from the Promotion. Mailed entries must be received by Sponsor no later than July 15, 2022 to be considered for the Promotion. Sponsor’s designated computer is the official time keeping device for this Promotion. No other forms of entry are valid. Limit one (1) entry per person.
