

ALL SMILES FOR THE JAGS PRESENTED BY ASAP DENTAL
OFFICIAL RULES

By entering into the All Smiles for the Jags presented by ASAP Dental (the “Promotion”), you agree to be bound by these Official Rules. Failure to comply with these Official Rules may result in disqualification from the Promotion.
