

P&G Jacksonville Jaguars Tackle Everything Sweepstakes

other Team personnel as determined by Team, a tour of TIAA Bank Field for the winner and one (1) guest; one (1) personalized replica Team Jersey, four (4) club level game tickets to one (1) Team home game played at TIAA Bank Field during the 2022/2023 preseason or regular season, one (1) parking pass to such Team home game (in a lot determined by Team) and four (4) pregame sideline passes to one (1) preseason or regular season home game played at TIAA Bank Field, and delivery of an at-home tailgate from the Team street team and members of the ROAR during one (1) Team away game determined by Team. The exact ticket locations shall be determined by Team. Approximate retail value of Grand Prize is \$3,500.
