

**2023 CROWN ROYAL "THAT DESERVES A CROWN" PROMOTION**  
**OFFICIAL TERMS & CONDITIONS**

***NO PURCHASE OR PAYMENT, BUSINESS RELATIONSHIP, OR REQUESTS FOR INFORMATION REQUIRED TO ENTER OR WIN. A PURCHASE OR PAYMENT, BUSINESS RELATIONSHIP, OR REQUEST FOR INFORMATION WILL NOT INCREASE YOUR CHANCES OF WINNING. YOU HAVE NOT WON YET. MUST BE 21 YEARS OF AGE OR OLDER TO SUBMIT A NOMINATION; MUST BE 25 YEARS OF AGE OR OLDER TO BE NOMINATED.***

By submitting a nomination application to enter the 2023 Crown Royal "That Deserves a Crown" Promotion (the "Promotion"), you agree to be bound by these terms and conditions. Failure to comply with these terms and conditions may (in the sole discretion of Jacksonville Jaguars, LLC ("Jaguars") and Diageo Americas, Inc. ("Crown Royal"), result in disqualification from the Promotion. To submit a nomination, you and the nominee must meet the eligibility requirements and follow the rules regarding the applications set forth herein.

The Promotion is void where prohibited or restricted by applicable laws, rules and legal requirements, and all applicable federal, state, municipal and local laws, rules and legal requirements apply. Jaguars and Crown Royal reserve the right to cancel, modify or suspend the Promotion at any time.

**Overview.** The Promotion is a program sponsored by the Jaguars and Crown Royal to promote leaders in the community in the northeast Florida and southeast Georgia region. Eligible persons are invited to submit a nomination application on behalf of a nominee who engages in charitable work and volunteerism or is a healthcare worker (who is not employed by any U.S. Federal, State or other governmental body/unit of any kind) to be awarded recognition and a prize (as described herein). A panel of Judges (as defined below) will use the Judging Criteria (as defined below) to judge the eligible nominations received. Subject to meeting all eligibility requirements relating to the Promotion and compliance with all terms and conditions, the five (5) selected nominees (each a "Winner") will each be featured in certain social media posts published to Jaguars' official social media account(s) and/or as part of a pregame video segment during a Jacksonville Jaguars home game played at EverBank Stadium during the 2023/24 NFL Season (each, a "Game") and will receive two (2) west club level tickets to one Game (i.e., the same game where the Winner may be featured in the pregame video segment), two (2) pregame sideline passes for use prior to the Game, one (1) single Game parking pass, one (1) \$1,000 charitable donation to a charity suggested by the Winner (the charitable organization shall be subject to the approval of the Jaguars and Crown Royal in their sole discretion and, if the Jaguars and Crown Royal do not approve of any of the charities suggested by the winner, the Jaguars/Crown Royal will make the \$1,000 charitable donation to a charity of their sole choosing), and a prize pack consisting of certain Crown Royal-branded items to be determined by Crown Royal (collectively, the "Award"), with a total approximate retail value of \$600. Each Award has a total approximate retail value as follows depending on the corresponding Game: (i) Kansas City Chiefs: \$529 per ticket + \$35 parking pass + \$600 Prize Pack = \$1,693; (ii) San Francisco 49ers: \$459 per ticket + \$35 parking pass + \$600 Prize Pack = \$1,553; (iii) Tennessee Titans: \$402 per ticket + \$35 parking pass + \$600 Prize Pack = \$1,439; (iv) Cincinnati Bengals: \$529 per ticket + \$35 parking pass + \$600 Prize Pack = \$1,693; and (v) Baltimore Ravens: \$459 per ticket + \$35 parking pass + \$600 Prize Pack = \$1,553. The Applicant (as defined below) who nominated the selected Winner will receive a prize pack consisting of certain Crown Royal-branded items to be determined by Crown Royal with a total approximate retail value of \$600. Winner's guest must be 21 years of age or older but need not be the person who submitted the application nominating the Winner for the Award. Additional details regarding the Award are set forth in the Application Site (as defined below) and all terms and conditions relating to the Award are subject to change at the sole discretion of the Jaguars or Crown Royal.

**How to Nominate.** To nominate a person for the Promotion, eligible persons must submit a complete and correct nomination application online at [www.jaguars.com/crownroyalpromotion](http://www.jaguars.com/crownroyalpromotion) (the "Application Site") between August 14, 2023 at 10:00:00 a.m. Eastern time and November 30, 2023 at 11:59:59 p.m. Eastern time. Internet access is required to submit an application. The completion of the application in its entirety will generate a nomination into the Promotion. **AN ELIGIBLE PERSON MUST SECURE THE CONSENT OF THE PERSON THEY WISH TO NOMINATE FOR THE PROMOTION BEFORE DOING SO; AND, AS PART OF SUCH CONSENT, SUCH ELIGIBLE PERSON SHOULD ADVISE NOMINEE OF THE NATURE OF THE AWARD INCLUDING THEIR AVAILABILITY ON ONE OF THE JAGUARS HOME GAME DATES (AS DISCUSSED BELOW.)** The information you provide in the application will be used to verify that you and the nominee meet eligibility requirements for the Promotion. Do NOT include any information that is confidential, proprietary or trade secret as part of the application. **ENTRIES MAY NOT BE MAILED.** Jaguars and Crown Royal reserve the right to extend the Promotion's nomination submission period at any time in their sole discretion.

Application is void and will not be considered if it includes any information determined by Jaguars and Crown Royal in their sole discretion to be obscene, provocative or otherwise objectionable or which reflects poorly on the Jaguars and/or Crown Royal. In addition, application shall NOT (a) reference persons consuming alcoholic beverages (b) reference persons conducting themselves in an inappropriate manner (c) contain material that would imply that the consumption of alcoholic beverages is acceptable before or while operating machinery, driving a vehicle or undertaking any other activity that requires a high degree of alertness

or physical coordination, (d) contain any material that would degrade or demean the human form, image or status of women, men or the members of any group based on race, religion, ethnic background, sexual orientation or any other minority status, or (e) include a reference to any person (in addition to nominee) that is under 21 years of age.

If accessing the Promotion via mobile device, wireless Internet access and/or other fees may apply. Please consult your wireless service provider regarding your pricing plan. Not all cellular phone providers carry necessary service to enter via mobile website. Wireless Internet access is not available in all areas.

### **Eligibility.**

Eligibility for individuals submitting a nomination (hereinafter, “Applicants”) in the Promotion is limited to persons who are 21 years of age or older as of August 14, 2023 and who are a legal U.S. resident of Florida or Georgia.

Eligibility for nominees of the Promotion are limited to individuals who are (a) 25 years of age or older as of August 14, 2023; and (b) legal U.S. residents of any of the following counties: (i) **Florida**: Nassau, Duval, Clay, St. Johns, Flagler, Putnam, Alachua, Bradford, Union, Baker, Columbia, Hamilton, Gilchrist, Suwannee, Lafayette, Marion, Lake, Volusia, Seminole, Orange, Brevard, Madison, Taylor, Dixie, Levy, Citrus, Sumter, Jefferson, Leon, Wakulla, Gadsden, Liberty, Franklin; (ii) **Georgia**: Brooks, Cook, Berrien, Lowndes, Lanier, Echols, Clinch, Atkinson, Ware, Coffee, Bacon, Appling, Pierce, Brantley, Wayne, Long, Liberty, Bryan, Bulloch, Effingham, Chatham, McIntosh, Glynn, Camden, Charlton, Evans, Tattnall.\*\*

### **\*\*For clarity, Applicants cannot nominate themselves.**

If selected, the Applicant and the nominee each will be asked to provide proof of eligibility in a format deemed acceptable to Jaguars and Crown Royal. A nomination (or “entry”) may only identify one person as the nominee. Only one entry per Applicant shall be considered. If multiple entries are received for a single nominee, the highest scored nomination for such nominee shall be considered. Any effort by an Applicant to misrepresent himself or herself (or the identity of any nominee) through the use of aliases or multiple e-mail addresses or telephone numbers or misrepresent his or her (or the nominee’s) eligibility age will disqualify that Applicant’s nomination and the Applicant’s nominee; however, disqualification shall not represent the sole remedy available to Jaguars or Crown Royal under such circumstances. Applications that have been generated by a script, macro, bot or any other automated means will be deemed void. Applications that are mechanically reproduced, copied, illegible, garbled, corrupted, inaccessible, jumbled, incomplete, invalid, late or inaccurate are void. Applicants who disregard or do not fully comply with these Official Terms and Conditions are not eligible to participate by submitting a nomination. Directors, officers, managers, members, employees, contractors and agents (and their immediate families and household members) of the Jaguars, Crown Royal, the NFL Entities (as defined herein), the Social Media Entities (as defined herein), and their respective parents, affiliates, subsidiaries, advertising and promotion agencies or of alcohol beverage suppliers, importers, wholesalers, distributors or retailers are not eligible to participate either as applicants or nominees. The Jaguars’ and Crown Royal’s determination of eligibility, in their sole discretion, shall be final. For purposes of these eligibility rules, “immediate family member” means a spouse, child, parent, parent of spouse, sibling, or spouse’s sibling.

### **Intellectual Property.**

By submitting a nomination, you represent and warrant that the application containing same is solely your original work product and does not violate the intellectual property rights (including copyright, trademark rights, right of publicity or right of privacy) or other rights of any third party, including but not limited to the nominee him/herself.

By submitting a nomination, you grant, without payment or consideration, the Jaguars and Crown Royal an unlimited, worldwide, royalty-free, perpetual, irrevocable, nonexclusive and freely transferable and sublicensable right and license to use, reproduce, modify, adapt, perform, display, distribute, create derivative works from and otherwise disclose to third parties any part and all of such application (including all written material and motion pictures, and all trademarks and logos of the nominee included therein) for any purpose, whether commercial or noncommercial, anywhere, in any form of media, whether now known or later developed. All materials submitted in connection with the Promotion become the property of Jaguars and Crown Royal and will not be returned. All materials submitted in connection with the Promotion shall be governed in accordance with the Jaguars’ Terms of Use, available in the footer section of [www.jaguars.com](http://www.jaguars.com) and these Official Terms and Conditions.

**Finalists Selection.** If an Applicant’s nominee is selected to receive an Award, the Applicant and the nominee will be notified by telephone or email on or about two (2) weeks prior to the applicable Game. Five (5) nominees shall be selected to receive an Award (and five [5] Applicants selected to receive a prize pack), but the Jaguars or Crown Royal reserve the right in their sole discretion to select more or fewer than five (5) nominees/Applicants for any reason. A given nominee may only win one (1) Award, regardless of the number of applications nominating him/her. The Jaguars or Crown Royal, in their sole discretion, will require the nominees and the applicants who nominated them to execute an affidavit, liability release, publicity release (except where prohibited by law), COVID-19 vaccination certification form (as applicable) and/or other documentation prior to the applicable Game. If any nominee fails to execute any required documentation, as determined by the Jaguars and Crown Royal, in their sole discretion, or fails to respond to the notification within 48 hours, the Jaguars and Crown Royal will consider the selected nominee to have forfeited participation in the Promotion and an alternative nominee may be selected, time permitting. Forfeiture of Award by selected nominee will also result in forfeiture of prize pack composed of Crown Royal and Jaguars-branded items by

the Applicant who nominated such selected nominee. The guest accompanying the Winner to the applicable game must also execute a release prior to the applicable game.

One (1) winner will be selected to receive an Award for each of the following Games listed below. The exact Game for which a Winner is selected will be determined by the Judges in their sole discretion. †All Jaguars Home Games are scheduled for kick-off at 1:00:00 p.m. Eastern Time, with the exception of the Jaguars Home Game vs the Cincinnati Bengals which is scheduled for kick-off at 8:15:00 p.m. Eastern Time and the Jaguars Home Game vs. the Baltimore Ravens which is scheduled for kick-off at 8:20:00 p.m. Eastern Time. Pursuant to the NFL’s flexible scheduling procedure, the date and/or kick-off time of each of the Jaguars Home Games may be shifted as follows:

- For the Jaguars Home Games vs. the Kansas City Chiefs (on September 17, 2023), vs. the San Francisco 49ers (on November 12, 2023) and vs. the Tennessee Titans (on November 19, 2023), the kick-off time of the Game may be shifted to 8:15:00 p.m. Eastern Time on the same date.
- For the Jaguars Home Game vs. the Cincinnati Bengals (on December 4, 2023), the date of the Game may be shifted to December 3, 2023 with kick-off time at 1:00 p.m. Eastern Time, 4:05 p.m. Eastern Time or 4:25 p.m. Eastern Time
- For the Jaguars Home Game vs. the Baltimore Ravens (on December 17, 2023), the kick-off time of the Game may be shifted to 1:00 p.m. Eastern Time, 4:05 p.m. Eastern Time or 4:25 p.m. Eastern Time.

Except for the Jaguars Home Game vs. the Baltimore Ravens (on December 17, 2023), any such change in kick-off date/time (as applicable) will be announced by the NFL no later than twelve (12) days prior to the Game Date. For the Jaguars Home Game vs. the Baltimore Ravens (on December 17, 2023), any such change in kick-off date/time (as applicable) will be announced by the NFL no later than six (6) days prior to the Game Date.

‡Nominees not selected for the Award corresponding to a given Jaguars Home Game will automatically be considered for subsequent Jaguars Home Game(s), as applicable. Accordingly, submitting an application closer to the beginning of the Promotion will increase the number of Jaguars Home Games for which the corresponding nominee will be considered.

**Judging Criteria.** Judges selected by the Jaguars and Crown Royal, in their sole discretion, with expertise in the fields of community relations and philanthropy (the “Judges”) will review the nomination applications received and select up to five (5) final nominees based on the following criteria (the “Judging Criteria”):

- 1) Applicant’s explanation of how his or her nominee contributes to their surrounding community (0-20 points);
- 2) Applicant’s explanation of how his or her nominee impacted him or her personally (0-20 points);
- 3) Applicant’s nominee’s potential to foster community growth (0-20 points);
- 4) Applicant’s nominee’s strategic objectives to serve the community (0-20 points); and
- 5) Applicant’s creativity and innovation with respect to the nomination application (0-20 points).

Based on the above criteria, five (5) final nominees with the highest scores as judged using the Judging Criteria on a rolling basis will be selected to receive an Award. The decisions of the Judges regarding the selection of the finalists, the Judging Criteria and all related matters are final. If a tie-breaker is necessary to determine the five (5) final nominees, the tie-breaking criteria will be based on the highest score relating to the Applicant’s explanation of how his or her nominee contributes to their surrounding community (0-100 points).

**Conditions of Participation.** Each Applicant represents and warrants that all information contained in his/her nomination application submission is, to the best of his/her knowledge and belief, true and accurate. Applicant (as well as nominee) further agrees, upon the request of the Jaguars and/or Crown Royal and without compensation, to fully cooperate in any investigation initiated by the Jaguars/Crown Royal so as to confirm the veracity of the information set forth in the nomination application. Jaguars and Crown Royal reserve the right to conduct a background check of any criminal records of Winners (and/or Applicants). To the extent necessary and permitted by law, Winners (and/or Applicants) shall authorize this background check. Jaguars and

Crown Royal reserve the right, at their sole discretion, to disqualify Winner based on the background check (of him/herself) and, if Winner is disqualified, the corresponding Applicant will also be disqualified (regardless of the results of background check on Applicant). If Applicant is disqualified, Jaguars and Crown Royal may (or may not) in their sole discretion also disqualify Winner. Jaguars and Crown Royal will not replace any lost, mutilated or stolen tickets. **Game tickets are only valid for the corresponding Jaguars Home Game.** Jaguars and Crown Royal are not responsible if the Game is delayed, postponed or cancelled for any reason and Winner will not receive compensation of any kind. Tickets may be subject to standard raincheck and cancellation policies and procedures. By accepting an Award that includes Game tickets, the Winner and Winner's guest agree to abide by any ticketback terms, conditions and restrictions, and all applicable Stadium and NFL rules and regulations, including with respect to COVID-19 protocols. Sponsor (i.e., the Jaguars and Crown Royal) is not responsible if Winner does not use the Game tickets on the day of the applicable Game and Sponsor shall not have any liability in conjunction therewith. The Award (as well as the prize pack comprised of Crown Royal and/or Jaguars-branded items awarded to Applicant who nominated Winner) is nontransferable and no substitution will be made except as provided herein at Jaguars'/Crown Royal's sole discretion. Redemption of the Award by Winner is a pre-condition to redemption of the prize pack by the corresponding Applicant.
