

2026 SPIRIT WEEK GIVEAWAYS PROMOTION
OFFICIAL RULES

By entering into the 2026 Spirit Week Giveaways Promotion (the “Promotion”), you agree to be bound by these Official Rules. Failure to comply with these Official Rules may result in disqualification from the Promotion. To enter, you must meet the eligibility requirements and follow the rules regarding Registrations (as defined below) set forth herein.
