

DUUUVAL SPIN TO WIN PRESENTED BY DAPPER LABS
OFFICIAL RULES

By entering into the Duuuval Spin to Win presented by Dapper Labs (the “Promotion”), you agree to be bound by these Official Rules. Failure to comply with these Official Rules may result in disqualification from the Promotion. To enter, you must meet the eligibility requirements and follow the rules regarding Registrations (as defined below) set forth herein.

The Promotion is void where prohibited or restricted by applicable laws, rules and legal requirements, and all applicable federal, state and local laws, rules and legal requirements apply. **Winners are responsible for any taxes, customs, duties and like amounts in respect of the Promotion prizes.** Jacksonville Jaguars, LLC (“Jaguars” or “Sponsor”) and Dapper Labs, Inc. (“Dapper Labs” or “Co-Sponsor”) reserve the right to cancel, modify or suspend the Promotion at any time.

The Promotion is powered by Wit Labs, Inc. (“Wit”) on behalf of Sponsor, and is accessible via the Wit website at witcontests.com, through a mobile device (collectively, the “Platform”). For the avoidance of doubt, Wit provides the Platform for the Promotion, but is not the sponsor for the Promotion.

1. **How to Enter.** To participate in the Promotion for a chance to win a Prize (as defined below), eligible persons must submit complete and correct registrations (“Registrations”) during the Entry Period (as defined below) by entering online through the Promotion landing page at <https://web.witcontests.com/jaguars/campaign/dapper-labs-spin-to-win-2025> (“Promotion Site”). Registrations will be accepted beginning at 12:00 am ET on Wednesday, November 12, 2025, until 11:59 pm ET on Tuesday, January 6, 2026 (the “Promotion Period”). The Promotion Period will be divided into five (5) separate entry periods corresponding to the week of each Jaguars Game depicted in the table below (each, an “Entry Period”), which Entry Periods shall occur from 12:00 am ET on the applicable start date through 11:59 pm on the applicable end date. Sponsor’s designated computer is the official time keeping device for this Promotion. No other forms of entry are valid. Limit one (1) Registration during the Promotion Period.

2. **Eligibility.** Eligibility to participate in the Promotion or to win a Prize is limited to persons who are 18 years of age or older at the time of entry and legal residents of one of the fifty (50) United States or the District of Columbia. Any effort by an entrant to misrepresent himself or herself through the use of aliases or multiple e-mail addresses or telephone numbers or misrepresent his or her eligibility age will disqualify that entrant. Entries that have been generated by a script, macro, bot or any other automated means will be deemed void. Entries that are mechanically reproduced, copied, illegible, incomplete, postage due, late or inaccurate are void. Entrants who disregard these Official Rules are not eligible to participate or win. 3. **Winner Selection.** Eligible persons who fully complete and return the Registration prior to the conclusion of the Promotion Period (“Registered Applicants”) shall be entered for a chance to win a Prize (as defined below). Five hundred (500) Secondary Prize (as defined below) winners per Entry Period (each, a “Secondary Prize Winner” and collectively, the “Secondary Prize Winners”) will be selected by a random generation by the Wit Platform during the Promotion Period. One (1) Grand Prize (as defined below) winner per Entry Period will be selected by a random drawing conducted by the Jaguars on or about the Wednesday following the applicable Entry

Period (approximate winner selection dates: November 19, 2025, November 26, 2025, December 3, 2025, December 17, 2025, January 7, 2026). Due to the variable nature of the number of Prizes remaining and Registered Applicants in the Promotion, the backend engine utilizes a dynamic probability function to determine Winners, based on an expected number of eligible Registrations. Therefore, the probability of winning a prize may vary throughout the course of the Entry Period. The number of Prizes available and the number of eligible Registrations received affect the odds of winning. Some prizes may be left unawarded at the end of the Entry Period if there are fewer eligible Registrations than expected. The Prize is nontransferable and no substitution will be made except as provided herein at Sponsor's sole discretion. Sponsor reserves the right to substitute the Prize (or any portion thereof) for one of equal or greater value if the Prize should become unavailable for any reason. Sponsor reserves the right to cancel, suspend and/or modify the Promotion, or any part of it, if any fraud, technical failures, human error or any other factor impairs the integrity or proper functioning of the Promotion, as determined by Sponsor in its sole discretion. In such event, Sponsor, in its sole discretion, may elect to hold a random drawing from among all eligible entries received up to the date of discontinuance for any or all of the Prizes offered herein. 6. **Publicity Rights; Marketing Opt-In.** By submitting a Registration, Registered Applicants grant to the Jaguars, Bold Events, LLC ("Bold Events"), Dapper Labs, each of their respective subsidiaries, affiliates, agents, and others working on their behalf, the right to use the Registered Applicant's name, likeness, voice, image, biographical information and any additional video or photographs taken by the Jaguars, Bold Events or their respective affiliates or representatives of the Registered Applicant during the Promotion for advertising and marketing purposes, including on the Promotion Site, in Jaguars or Bold Events or Dapper Labs social media, and in Jaguars or Bold Events or Dapper Labs emails, without additional compensation. 7. **Winner Notification.** A Registered Applicant that is randomly selected to be a Secondary Prize Winner will be notified instantly within the Wit Platform then directed to the Dapper Labs website and must follow the provided instructions to claim the Secondary Prize. A Registered Applicant that is randomly selected to be a Grand Prize Winner will be notified by the Jaguars via email on or around the Wednesday following the applicable Entry Period. Sponsor may require the Grand Prize Winners to execute an affidavit of eligibility, publicity release (except where prohibited), and liability waiver and other documentation prior to the delivery of the Grand Prize (an "Affidavit"). The Grand Prize Winners may be required to provide a Form W-9 to receive the Prize. The Grand Prize Winners will receive an IRS Form 1099 from Sponsor for the approximate retail value of the Prize for the calendar year won. 10. **Disclaimers, Dispute Resolution and Limitations of Liability.** Each Registered Applicant hereby forever discharges, releases, and agrees to defend, indemnify and hold harmless the Jaguars, Bold Events, Dapper Labs, the National Football League, the NFL Entities (as defined herein), the Social Media Entities (as defined herein), and those working on their behalf, and each of their respective officers, members, managers, directors, representatives, employees, agents, successors and assigns, subsidiaries and affiliates from any damage, injury, death, loss or other liability, either at law or equity, whether known or unknown, asserted or non-asserted, that may arise from or in any way relate to participation in this Promotion or the awarding, acceptance, use or misuse of any prize given out under the Promotion or any other substitute prize. Any and all disputes, claims, and causes of action arising out of or in connection with this Promotion shall be resolved individually, without resort to any form of class action. The arbitration shall be administered by AAA pursuant to its Comprehensive Arbitration Rules

and Procedures and in accordance with the Expedited Procedures in those Rules. Judgment on the award may be entered in any court having jurisdiction. This clause shall not preclude Sponsor or Registered Applicant from seeking provisional remedies in aid of arbitration from a court of appropriate jurisdiction. Entrants agree to abide by the terms of these Official Rules and the decisions of Sponsor, which are final, and waive any right to claim ambiguity in these Official Rules. Each Registered Applicant agrees to service of process by mail or other method acceptable under the laws of the State of Florida. ANY CLAIMS, JUDGMENTS AND/OR AWARDS SHALL BE LIMITED TO ACTUAL OUT-OF-POCKET COSTS ASSOCIATED WITH ENTERING THIS PROMOTION. 11. **Severability.** In the event that any provision of these Official Rules shall be declared invalid or unenforceable for any reason by a court of competent jurisdiction, such provision shall be severed from the remainder of these Official Rules, which shall remain in full force and effect, and the Official Rules shall be construed as if such invalid or unenforceable provision had not been part of the Official Rules, and the court making such determination shall have the power to reduce the scope or applicability of such provision in a manner that makes such provision valid and enforceable and comes closest to expressing the intention of the invalid or unenforceable provision.
