

**MY 1<sup>ST</sup> DOWN WITH THE JAGUARS CONTEST**  
**OFFICIAL TERMS & CONDITIONS**

**NO PURCHASE IS NECESSARY TO ENTER OR WIN.  
A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING.**

By submitting an entry to enter the My 1<sup>st</sup> Down with the Jaguars Contest (the “Contest”), you agree to be bound by these terms and conditions. Failure to comply with these terms and conditions may in the discretion of Jacksonville Jaguars, LLC (“Jaguars” or “Sponsor”) and Ticketmaster L.L.C. (“Ticketmaster”) or “Co-Sponsor”) result in disqualification from the Contest. To submit an entry, you must meet the eligibility requirements and follow the rules regarding the registration set forth herein.

The Contest is void where prohibited or restricted by applicable laws, rules and legal requirements, and all applicable federal, state, municipal and local laws, rules and legal requirements apply. Sponsor reserves the right to cancel, modify or suspend the Contest at any time.

**Overview.** The Contest is designed by the Jaguars to encourage fans who have never been to a Jaguars game to enter and share their stories about their fandom. Eligible persons are invited to submit a registration to be awarded a Prize (as defined below). A panel of Judges (as defined below) will use the Judging Criteria (as defined below) to judge the registrations received. Subject to meeting all eligibility requirements relating to the Contest and compliance with all terms and conditions, the selected top Entrant that submits the best written submission based on the Judging Criteria (the “Winner”) will receive the following: (i) two (2) tickets and one (1) parking pass to the Jaguars home game versus the Tennessee Titans scheduled to be played during Week 18 of the 2025/26 NFL regular season (the “Game”) (ARV = \$500), (ii) two (2) custom Jaguars replica jerseys (ARV = \$400), and (iii) the opportunity for Winner and one (1) guest to receive a VIP pregame sideline experience prior to the Game. **Total ARV of the Prize = \$900.00.** The exact ticket location for the Game shall be determined by the Jaguars in its sole discretion. Jaguars will not replace any lost, mutilated, or stolen tickets. Jaguars are not responsible if the Game is delayed, postponed, or cancelled for any reason and Winner will not be reimbursed for any Game tickets. By accepting a prize that includes tickets, the Winner and Winner’s guest (if applicable) agree to abide by any ticketback terms, conditions and restrictions, and all applicable venue rules and regulations, including with respect to health and safety protocols. Released Parties are not responsible if Winner does not use Game tickets. Sponsor reserves the right to remove or to deny attendance to any Winner and/or guest who engages in a non-sportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any other person at the Game.

**How to Enter.** To submit an entry for the Contest, eligible persons (“Entrants”) must submit a complete and correct registration (“Registrations”) by submitting a written submission advocating why they should be selected to win the Prize at <https://web.witcontests.com/jaguars/sweepstakes/win/my-first-down-with-the-jags-251222> between 10:00 a.m. Eastern time on December 23, 2025 and at 11:59:59 p.m. Eastern time on December 28, 2025 (“Submission Period”). The completion of the Registration in its entirety in accordance with these Official Terms and Conditions will automatically generate your submission into the Contest. The information you provide in the Registration will be used to verify that you meet eligibility requirements for the Contest. **ENTRIES MAY NOT BE MAILED.** Only one (1) entry per Entrant shall be considered. Jaguars reserve the right to change the Contest’s Submission Period at any time in its sole discretion.

**Eligibility.** Eligibility to participate in the Contest or to win a Prize is limited to persons who are 18 years of age or older at the time of entry and legal residents of the state of Florida or Georgia. Any effort by an Entrant to misrepresent himself or herself through the use of aliases or multiple e-mail addresses or telephone numbers or misrepresent his or her eligibility age will disqualify that Entrant. Entries that have been generated by a script, macro, bot or any other automated means will be deemed void. Entries that are mechanically reproduced, copied, illegible, incomplete, postage due, late or inaccurate are void. Entrants who disregard these Official Terms and Conditions are not eligible to participate or win. **Intellectual Property.** Except as prohibited by law, by submitting an entry, you grant, without payment or consideration, the Jaguars an unlimited, worldwide, royalty-free, perpetual, irrevocable, nonexclusive and freely transferable and sublicensable right and license to use, reproduce, modify, adapt, perform, display, distribute, create derivative works from and otherwise disclose to third parties any part and all of such Registration (including all written material, photos, and motion pictures, and all trademarks and logos of the Entrant included therein) for any purpose, whether commercial or noncommercial, anywhere, in any form of media, whether now known or later developed. All materials submitted in connection with the Contest become the property of Jaguars and will not be returned. All materials submitted in connection with the Contest shall be governed in accordance with Sponsor’s Terms of Use, available in the footer section of [www.jaguars.com](http://www.jaguars.com), and these Official Terms and Conditions.

**Judging Criteria.** Judges selected by the Jaguars in its sole discretion (the "Judges") will review the Registrations received and select one (1) Winner based on the following criteria (the "Judging Criteria"):

- Entrant's creativity (0-30 points), enthusiasm (0-30 points) and showcasing their pride in the Jaguars (0-40 points).

Based on the above criteria, one (1) Winner with the highest point total from the Judges criteria will be selected to receive the Prize. In the event of a tie, all tied highest point totals will be re-judged based on the following criteria: Entrant's creativity (0-100 points). The decisions of the Judges regarding the selection of the Winner, the Judging Criteria, and all related matters are final and binding.

Entries that are deemed by the judges in their sole discretion to be immoral, obscene, profane or not in keeping with the Jaguars image or in violation of these Official Rules will be void. In addition, to be eligible, Entry cannot include any third-party intellectual property, general property, likeness or imagery. Entry cannot defame or invade intellectual property rights of any person, living or deceased, or otherwise infringe upon any copyrighted, trademarked, or patented works or person's personal or proprietary rights. All Entries become the exclusive property of the Jaguars, and none will be acknowledged or returned.

**Winner Selection.** If an Entrant is selected to receive the Prize, the Entrant will be notified by telephone or email on or about December 29, 2025. One (1) Prize winner (the "Winner") shall be selected by the Jaguars in its sole discretion and may require the Winner to execute an affidavit of eligibility, publicity release (except where prohibited), and liability waiver and other documentation prior to the delivery of the Prize (an "Affidavit"). The Winner must provide a Form W-9 to receive the Prize. The Winner will receive an IRS Form 1099 from Sponsor for the approximate retail value of the Prize for the calendar year won. If the Winner fails to pick up or redeem the Prize at the location designated by the Jaguars on a date and time designated by the Jaguars, fails to execute the Affidavit or other documentation required by the Jaguars, or fails to respond to the notification within 48 hours, the Jaguars will consider such Winner to have forfeited the Prize and another prize winner may be selected.
