

FOUR-LEGGED FAN CLUB PET OF THE GAME SWEEPSTAKES
OFFICIAL RULES

By entering into the Four-Legged Fan Club Pet of the Game Sweepstakes (the “Promotion”), you agree to be bound by these Official Rules. Failure to comply with these Official Rules may result in disqualification from the Promotion. Sponsor’s designated computer is the official time keeping device for this Promotion. No other forms of entry are valid. Limit one (1) entry per Registered Applicant (as defined below) per pet during the Entry Period.

2. **Eligibility.** Eligibility to participate in the Promotion or to win a Prize is limited to persons who are 18 years of age or older as of July 27, 2026 and legal residents of one of the fifty (50) United States or the District of Columbia. Entries that have been generated by a script, macro, bot or any other automated means will be deemed void. †All Jaguars Home Games are scheduled for kick-off at 1:00:00 p.m. Eastern Time, with the exception of the preseason Jaguars Home Games (vs the Carolina Panthers and Tampa Bay Buccaneers) which are scheduled for kick-off at 7:30:00 p.m. Eastern Time. The kick-off time of each of the Jaguars Home Games may be shifted pursuant to the NFL's flexible scheduling procedure.

‡ Registered Applicants who do not win a Prize corresponding to a given Jaguars Home Game will automatically be entered for a chance to win the subsequent Jaguars Home Game(s), as applicable.
