

GAMEDAY ICE SWEEPSTAKES PRESENTED BY DIAMONDS DIRECT
OFFICIAL RULES

By entering into the Gameday Ice Sweepstakes presented by Diamonds Direct (the “Promotion”), you agree to be bound by these Official Rules. Failure to comply with these Official Rules may result in disqualification from the Promotion. To enter, you must meet the eligibility requirements and follow the rules regarding Registrations (as defined below) set forth herein.

1. **How to Enter.** To participate in the Promotion for a chance to win a Prize (as defined below), eligible persons must submit complete and correct registrations (“Registrations”) during the Entry Period by (i) entering online through the Promotion landing page at <https://www.jaguars.com/diamonds> (“Promotion Site”). Registrations will be accepted beginning at 10:00 am ET on November 14, 2022, until 11:59 pm ET on November 28, 2022 (the “Entry Period”). Sponsor’s designated computer is the official time keeping device for this Promotion. No other forms of entry are valid. Limit one (1) entry per person.

2. **Eligibility.** Eligibility to participate in the Promotion or to win a Prize is limited to persons who are 18 years of age or older as of November 14, 2022, and legal residents of the state of Florida or Georgia. 4. **Prize.** The prize for this Promotion shall consist of the following (the “Prize”): one (1) Winner shall receive (i) two (2) tickets and two (2) pre-game sideline passes to one (1) to be determined Jaguars home game (ARV = \$758), (ii) one (1) autographed Jaguars-branded merchandise item (ARV= \$250), and (iii) the opportunity for Winner to choose one (1) jewelry set from three (3) preselected jewelry set options provided by Diamonds Direct. (ARV = \$6,660 (Option 1), \$5,300 (Option 2), or \$8,000 (Option 3). **Total ARV of Prize: Between \$6,308.00 and \$9,009.00.**

The Prize is nontransferable and no substitution will be made except as provided herein at Sponsor’s sole discretion.
