

**JAGUARS JUNIOR FIRE CHIEF OF THE GAME**  
**OFFICIAL RULES**

By entering into the Jaguars Junior Fire Chief of the Game (the “Promotion”), you agree to be bound by these Official Rules. Failure to comply with these Official Rules may result in disqualification from the Promotion. To enter, you must meet the eligibility requirements and follow the rules regarding Registrations (as defined below) set forth herein.

The Promotion is void where prohibited or restricted by applicable laws, rules and legal requirements, and all applicable federal, state and local laws, rules and legal requirements apply. **Winners are responsible for any taxes, customs, duties and like amounts in respect of the Promotion prizes.** Jacksonville Jaguars, LLC (“Jaguars” or “Sponsor”) reserves the right to cancel, modify or suspend the Promotion at any time.

1. **How to Enter.** To participate in the Promotion for a chance to win a Prize (as defined below), eligible persons must submit complete and correct registrations (“Registrations”) during the Entry Period (as defined below) by entering online through the Promotion landing page at <https://web.witcontests.com/jaguars/sweepstakes/win/jaguars-junior-fire-chief-of-t-240722> (“Promotion Site”). Registrations will be accepted beginning at 10:00 am ET on August 1, 2024 until 11:59 pm ET on December 12, 2024 (the “Entry Period”). Sponsor’s designated computer is the official time keeping device for this Promotion. No other forms of entry are valid. Limit one (1) entry per person per day during the Entry Period.

2. **Eligibility.** Eligibility to participate in the Promotion or to win a Prize is limited to persons who are 18 years of age or older at the time of entry that are the parent/legal guardian of a child from 4 to 12 years of age and legal residents of the state of Florida or Georgia. Entries that have been generated by a script, macro, bot or any other automated means will be deemed void. 4. **Prize.** Nine (9) Winners will each receive the following prize (the “Prize”) consisting of: (i) four (4) general bowl tickets (ARV = \$93 per ticket), and (ii) one (1) parking pass to one (1) above referenced Jaguars Home Game (ARV = \$40); (iii) a Firehouse Subs-branded prize pack containing a bandana, bucket hat, sub coupon, and sticker book to be provided by Firehouse Subs (ARV = \$275); and (iv) each Winner’s child will be identified as the Jaguars Junior Fire Chief of the Game and receive the opportunity to sit in a fire truck during the respective Jaguars Home Game. **Total ARV of all Prizes = \$6,183.**

The exact ticket locations shall be determined by Sponsor in its sole discretion. Sponsor will not replace any lost, mutilated, or stolen tickets. Sponsor is not responsible if the Game is delayed, postponed or cancelled for any reason and Winner will not be reimbursed for tickets or the passes. Tickets and passes may be subject to standard raincheck and cancellation policies and procedures. By accepting a Prize that includes Game tickets, each Winner agrees to abide by any ticketback terms, conditions and restrictions, any use restrictions applicable to the passes, all applicable EverBank Stadium and NFL rules and regulations, and Sponsor’s instructions during the Promotion. Winner shall exercise control over the minor child at all times and provide supervision while the child sits in the firetruck. Sponsor is not responsible if Winner does not use the tickets or passes on the day of the Game. All expenses and incidental costs not expressly stated in the package description above, including but not limited to ground transportation, incidentals, gratuities, taxes or other expenses are the sole responsibility of Winner. The Prize is non-transferable and no substitution will be made except as provided herein at the Sponsor’s sole discretion. Sponsor reserves the right to substitute the Prize (or a component thereof) for one of equal or greater value if the designated Prize should become unavailable for any reason. 5. **Conditions of Participation.** Each participant in the Promotion agrees to be bound by these Official Rules and the decisions of Sponsor (which shall be final), and to accept delivery of the Prize. In addition, each Registered Applicant represents and warrants that all information contained in his/her Registration entry is true and accurate and that it Registered Applicant is the parent or legal guardian of the minor child participating in the Promotion. Sponsor is not responsible for any printing errors in these Official Rules, in the Registration page or otherwise in any materials in connection with the Promotion or for any misdirected, incomplete, lost, late or illegible Registrations or other errors or problems that may limit a participant’s ability to participate in or win the Promotion. In such event, Sponsor, in its sole discretion, may elect to hold a random drawing from among all eligible entries received up to the date of discontinuance for any or all of the Prizes offered herein. 7. **Winner Notification.** The Prize Winners will be notified by telephone or email in accordance with the table set forth in Section 3. Sponsor may require the Winner to execute an affidavit of eligibility, publicity release (except where prohibited), and liability waiver and other documentation prior to the delivery of the Prize (an "Affidavit"). The Winner must provide a Form W-9 to receive the Prize. The Winner will receive an IRS Form 1099 from Sponsor for the approximate retail value of the Prize for the calendar year won. If the Winner fails to pick up or redeem the Prize at the location designated by the Jaguars on a date and time designated by the Jaguars, or fails to execute the Affidavit or other documentation required by the Jaguars, the Jaguars will consider such Winner to have forfeited the Prize and another prize winner will be selected. In the event that the potential winner is disqualified for any reason, Sponsor will award the Prize to an alternate winner through a random drawing from remaining Registrations. Only three (3) alternate awards will be attempted, after which the Prize will remain unawarded. The right to receive the Prize is non-transferable and the Winner has no right of substitution (in cash or otherwise). Sponsor reserves the right to substitute a prize of equal or greater value in the event any portion of the Prize is unavailable, as determined by Sponsor in its sole discretion.

10. **Disclaimers, Dispute Resolution and Limitations of Liability.** Each Registered Applicant for itself and behalf of Registered Applicant's minor child, should such child receive a prize or any component thereof, in connection with this Promotion, hereby forever discharges, releases, and agrees to defend, indemnify and hold harmless the Jaguars, Firehouse Subs, Bold Events, the National Football League, the Social Media Entities (as defined herein) the NFL Entities (as defined herein), and those working on their behalf, and each of their respective officers, members, managers, directors, representatives, employees, agents, successors and assigns, parent, subsidiaries, franchisees, and affiliates from any damage, injury, death, loss or other liability, either at law or equity, whether known or unknown, asserted or non-asserted, that may arise from or in any way relate to participation in this Promotion or the awarding, acceptance, use or misuse of any prize given out under the Promotion or any other substitute prize. The arbitration shall be administered by AAA pursuant to its Comprehensive Arbitration Rules and Procedures and in accordance with the Expedited Procedures in those Rules. Judgment on the award may be entered in any court having jurisdiction. This clause shall not preclude Sponsor or Registered Applicant from seeking provisional remedies in aid of arbitration from a court of appropriate jurisdiction. Entrants agree to abide by the terms of these Official Rules and the decisions of Sponsor which are final, and waive any right to claim ambiguity in these Official Rules. Each Registered Applicant agrees to service of process by mail or other method acceptable under the laws of the State of Florida. ANY CLAIMS, JUDGMENTS AND/OR AWARDS SHALL BE LIMITED TO ACTUAL OUT-OF-POCKET COSTS ASSOCIATED WITH ENTERING THIS PROMOTION. REGISTERED APPLICANT HEREBY WAIVES ANY RIGHTS OR CLAIMS TO ATTORNEYS' OR OTHER PROFESSIONALS' FEES, INDIRECT, SPECIAL, PUNITIVE, INCIDENTAL OR CONSEQUENTIAL DAMAGES OF ENTRANT, WHETHER FORESEEABLE OR NOT AND WHETHER BASED ON NEGLIGENCE OR OTHERWISE. 11. **Severability.** In the event that any provision of these Official Rules shall be declared invalid or unenforceable for any reason by a court of competent jurisdiction, such provision shall be severed from the remainder of these Official Rules, which shall remain in full force and effect, and the Official Rules shall be construed as if such invalid or unenforceable provision had not been part of the Official Rules, and the court making such determination shall have the power to reduce the scope or applicability of such provision in a manner that makes such provision valid and enforceable and comes closest to expressing the intention of the invalid or unenforceable provision.
