

**GUESS THE JAGUARS 2026 SCHEDULE SWEEPSTAKES**  
**PRESENTED BY DREAM FINDERS HOMES**  
**OFFICIAL RULES**

By entering into the Guess the Jaguars 2026 Schedule Sweepstakes presented by Dream Finders Homes (the “Promotion”), you agree to be bound by these Official Rules. Failure to comply with these Official Rules may result in disqualification from the Promotion. To enter, you must meet the eligibility requirements and follow the rules regarding Registrations (as defined below) set forth herein.

**A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING.**

The Promotion is void where prohibited or restricted by applicable laws, rules and legal requirements, and all applicable federal, state and local laws, rules and legal requirements apply. **Winners are responsible for any taxes, customs, duties and like amounts in respect of the Promotion prizes.** Jacksonville Jaguars, LLC (“Jaguars” or “Sponsor”) reserves the right to cancel, modify or suspend the Promotion at any time.

1. **How to Enter.** To participate in the Promotion for a chance to win a Prize (as defined below), eligible persons must submit complete and correct registrations (“Registrations”) during the Entry Period by entering online through the Promotion landing page at [Jaguars Schedule Predictor 2026 - Jacksonville Jaguars x Dream Finders Homes](#) (“Promotion Site”). Registrations will be accepted beginning at 10:00 a.m. EST on April 17, 2026 until 11:59 p.m. EST on April 30, 2026 (the “Entry Period”). DESPITE THE APRIL 30, 2026 ENTRY DEADLINE, YOU ACKNOWLEDGE THAT THE NFL SCHEDULE IS NOT EXPECTED TO BE FINALIZED UNTIL EARLY TO MID MAY 2026.

For purposes of clarity, a Registration is “complete and correct” when it identifies an opponent for each Jacksonville Jaguars game during the 2026 regular season by matching the opponent’s team name to a designated week during the regular season as set forth on the Promotion Site. Entrants will not have the ability to edit or otherwise make changes to their selections once the Registration has been submitted.

Sponsor’s designated computer is the official time keeping device for this Promotion. No other forms of entry are valid. Limit one (1) entry per person during the Entry Period.

2. **Eligibility.** Eligibility to participate in the Promotion or to win a Prize is limited to persons who are 18 years of age or older as of April 17, 2026, and legal residents of the state of Florida or Georgia. Any effort by an entrant to misrepresent himself or herself through the use of aliases or multiple e-mail addresses or telephone numbers or misrepresent his or her eligibility age or identity will disqualify that entrant. Entries that have been generated by a script, macro, bot or any other automated means will be deemed void. Entries that are mechanically reproduced, copied, illegible, incomplete, postage due, late or inaccurate are void. Entrants who disregard these Official Rules are not eligible to participate or win. - **Grand Prize:** One (1) Grand Prize Winner will be selected by random drawing from all Registered Applicants who correctly identifies the entire Jacksonville Jaguars 2026 NFL Regular Season Schedule (including the bye week) (the “Jags Schedule”) in order. - **Four (4) Additional Prizes:** Four (4) runner-up prize Winners will be randomly selected from all Registered Applicants who most accurately predict the Jags Schedule in order. If there are no

Registered Applicants who accurately predict any game in the Jags Schedule in order, the remaining prize Winners will be randomly selected from all Registered Applicants. Sponsor reserves the right to change the drawing date and time in its sole discretion. Odds of winning depend on the number of Registrations received. 7. **Winner Notification.** The Winner will be notified by telephone or email on a reasonable date following the 2026 Jaguars regular season schedule release from the NFL in May 2026. Sponsor may require Winners to execute an affidavit of eligibility, publicity release (except where prohibited), and liability waiver and other documentation prior to the delivery of a Prize (an "Affidavit"). The Winner must provide a Form W-9 to receive a Prize. Winner will receive an IRS Form 1099 from the Sponsor for the approximate retail value of the Prize for the calendar year won. This clause shall not preclude Sponsor or Registered Applicant from seeking provisional remedies in aid of arbitration from a court of appropriate jurisdiction. Entrants agree to abide by the terms of these Official Rules and the decisions of Sponsor, which are final, and waive any right to claim ambiguity in these Official Rules. Each Registered Applicant agrees to service of process by mail or other method acceptable under the laws of the State of Florida.
