

**THE SHADOWS SWEEPSTAKES**  
**OFFICIAL RULES**

By entering into The Shadows Sweepstakes (the “Promotion”), you agree to be bound by these Official Rules. Failure to comply with these Official Rules may result in disqualification from the Promotion. To enter, you must meet the eligibility requirements and follow the rules regarding Registrations (as defined below) set forth herein.

The Promotion is void where prohibited or restricted by applicable laws, rules and legal requirements, and all applicable federal, state and local laws, rules and legal requirements apply. **Winners are responsible for any taxes, customs, duties and like amounts in respect of the Promotion prizes.** Jacksonville Jaguars, LLC (“Jaguars” or “Sponsor”) reserves the right to cancel, modify or suspend the Promotion at any time.

1. **How to Enter.** To participate in the Promotion for a chance to win a Prize (as defined below), eligible persons must submit complete and correct registrations (“Registrations”) during the Entry Period by (i) entering online through the Promotion landing page at [jaguars.com/shadows](http://jaguars.com/shadows) (“Promotion Site”). Registrations will be accepted beginning at 10:00 am ET on September 1, 2022 until 11:59 pm ET on January 1, 2023 (the “Entry Period”). Sponsor’s designated computer is the official time keeping device for this Promotion. No other forms of entry are valid. Limit one (1) entry per person.

2. **Eligibility.** Eligibility to participate in the Promotion or to win a Prize is limited to persons who are 18 years of age or older as of September 1, 2022 and legal residents of the state of Florida or Georgia. 4. **Prize.** Each Winner will receive the following prize (the “Prize”) consisting of: (i) two (2) field seats to one (1) above referenced Jaguars Home Game (ARV = \$842), (ii) one (1) parking pass (ARV = \$30), (iii) one (1)

merchandise item autographed by a current Jaguars player (ARV = \$150), and (iv) "The Shadows" pregame experience for two (2) guests. **Total ARV of all Prizes = \$7,154.**

The exact ticket locations shall be determined by Sponsor in its sole discretion. Sponsor will not replace any lost, mutilated, or stolen tickets. Sponsor is not responsible if the Game is delayed, postponed or cancelled for any reason and Winner will not be reimbursed for tickets or the passes. Tickets and passes may be subject to standard raincheck and cancellation policies and procedures.
