

VERIZON JACKSONVILLE JAGUARS TICKET SWEEPSTAKES
OFFICIAL RULES

By entering into the Verizon Jacksonville Jaguars Ticket Sweepstakes (the “Promotion”), you agree to be bound by these Official Rules. Failure to comply with these Official Rules may result in disqualification from the Promotion. To enter, you must meet the eligibility requirements and follow the rules regarding Registrations (as defined below) set forth herein.

Registrations will be accepted beginning at 9:00 am ET on October 13, 2025 until 11:59 pm ET on November 2, 2025 (the “Entry Period”). Sponsor’s designated computer is the official time keeping device for this Promotion. No other forms of entry are valid. **Limit one (1) entry per person and per email address during the Entry Period.**

2. **Eligibility.** Eligibility to participate in the Promotion and/or to win a Prize is limited to persons who are 18 years of age or older as of the date of entry and legal residents of the state of Florida or Georgia. Any effort by an entrant to misrepresent himself or herself through the use of aliases or multiple e-mail addresses or telephone numbers or misrepresent his or her eligibility age will disqualify that entrant. Entries that have been generated by a script, macro, bot or any other automated means will be deemed void. - Four (4) lower bowl tickets to the Jaguars home game versus the Los Angeles Chargers scheduled to be played on November 16, 2025 at EverBank Stadium, 1 EverBank Stadium Dr, Jacksonville, FL 32202 (“Live Event”) (ARV = \$286.00 per ticket).

Total ARV of the Prize = \$1,144.00

The exact ticket locations for the above-referenced Live Event shall be determined by Sponsor in its sole discretion. Neither Sponsor nor Co-Sponsor will replace any lost, mutilated, or stolen tickets. Neither Sponsor nor

Co-Sponsor are responsible if the Live Event is delayed, postponed, or cancelled for any reason and Winner will not be reimbursed for the Live Event tickets. Live Event may be subject to standard raincheck and cancellation policies and procedures.
