

Jets Flyaway Experience Sweepstakes

Official Rules

No Purchase Necessary to Enter or Win. A Purchase will Not Increase Your Chances of Winning.

This Promotion may be modified, canceled or postponed by Sponsor at any time in its sole discretion due to the ongoing pandemic (e.g., Coronavirus/COVID-19).

Eligibility: The Jets Flyaway Experience Sweepstakes (hereafter, "Sweepstakes") is open to legal permanent residents of Connecticut, New Jersey & New York who are eighteen (18) years of age or older as of the date of entry. Employees, officers, directors, agents and representatives of New York Jets LLC ("Sponsor"), the National Football League, its member professional football clubs, NFL Ventures, L.P., teamDigital Promotions, Inc. ("teamDigital"), and each of their respective parents, affiliates, subsidiaries, wholesalers, retailers, distributors, suppliers, advertising and promotion agencies (hereafter collectively, "Released Parties"), and each such individual's immediate family members (mother, father, sister, brother, child, husband, wife and their respective spouses, regardless of where they reside) and those living in their same households, whether or not related, are not eligible to participate or win. All entries must be received by 8:59:59 pm ET on August 6, 2022 to be eligible. **Limit one (1) entry per person, per email address and per household throughout the Promotion Period. You may only use one (1) email address to enter the Sweepstakes.
