NY Jets Autographed Rookie Poster Sweepstakes Official Rules

No Purchase or Text Message Necessary to Enter or Win. A Purchase or Text Message will Not Increase Your Chances of Winning.

This Sweepstakes, including any entry method or prize offered, may be cancelled or postponed by Sponsor, in full or in part, at any time, due to reasons related to the ongoing pandemic (e.g., Coronavirus/Covid-19).

Eligibility: The NY Jets Autographed Rookie Poster Sweepstakes (hereafter, "Sweepstakes") is open to legal residents of the fifty (50) U.S. (including D.C.) who are at least eighteen (18) years old at the time of entry (hereafter, "Eligible Entrants").
