

## Choose Fun this Holiday Season Sweepstakes

### Official Rules

#### **No Purchase Necessary to Enter or Win. A Purchase will Not Increase Your Chances of Winning.**

**Eligibility:** The Choose Fun this Holiday Season Sweepstakes (hereafter, "Sweepstakes") is open to legal permanent residents of the 50 United States (and the District of Columbia) who are at least eighteen (18) years of age at the time/date of entry (hereafter, "Eligible Entrants").
