

## WEEK 3 VS. NEW ENGLAND PATRIOTS TICKETS OFFICIAL RULES

NO PURCHASE OR MOBILE DEVICE NECESSARY TO ENTER OR WIN. A PURCHASE OR MOBILE DEVICE WILL NOT IMPROVE YOUR CHANCES OF WINNING.

**SWEEPSTAKES ENTRY PERIOD:** The **Week 3 vs. New England Patriots** (the "Sweepstakes") begins at **9:00 AM** Eastern Time ("ET") on **Friday, May 26, 2023**, and ends at **9 AM** Eastern Time ("ET") on **Saturday, May 27, 2023** (the "Sweepstakes Period").
