## Home Opener Experience Sweepstakes Official Rules

No Purchase or Text Message Necessary to Enter or Win. A Purchase or Text Message will Not Increase Your Chances of Winning.

Eligibility: The Home Opener Experience Sweepstakes (hereafter, "Sweepstakes") is open to legal residents of New York, New Jersey, Pennsylvania and Connecticut who are at least eighteen (18) years of age at the time of entry (hereafter, "Eligible Entrants").
