

## Home Opener Experience Sweepstakes Official Rules

**No Purchase or Text Message Necessary to Enter or Win. A Purchase or Text Message will Not Increase Your Chances of Winning.**

**Eligibility:** The Home Opener Experience Sweepstakes (hereafter, "Sweepstakes") is open to legal residents of New York, New Jersey, Pennsylvania and Connecticut who are at least eighteen (18) years of age at the time of entry (hereafter, "Eligible Entrants"). Employees, officers, directors, agents and representatives of New York Jets LLC ("Sponsor"), Ticketmaster Entertainment, LLC ("Presenting Partner"), the National Football League, its member professional football clubs, NFL Ventures, L.P., teamDigital Promotions, Inc. ("teamDigital"), and each of their respective parents, affiliates, subsidiaries, wholesalers, retailers, distributors, suppliers, advertising and promotion agencies (hereafter collectively, "Released Parties"), and each such individual's immediate family members (mother, father, sister, brother, child, husband, wife and their respective spouses, regardless of where they reside) and those living in their same households, whether or not related, are not eligible to participate or win. **Promotion Period:** Sweepstakes begins 12:00:00 am Eastern Time ("ET") on 8/23/24 and ends 11:59:59 pm ET on 9/8/24 (hereafter, "Promotion Period").

**How to Enter:** During the Promotion Period, Eligible Entrants will have the opportunity to enter the Sweepstakes via one (1) of the following two (2) ways:

1) Opt-in To Receive Text Messages: Eligible Entrants must first text the keyword "OPENER" to 26154 from their mobile device. Upon completion, Eligible Entrant will receive an automated text message from the New York Jets confirming their desire to opt-in to receive future text messages. By responding "Y" to the automated text message, Eligible Entrant will receive one (1) entry. Eligible Entrant will be charged standard messaging and/or data rates for each text message sent from and received by their device according to the terms of their wireless service agreement. Eligible Entrant must be a wireless service subscriber with text messaging functionality to enter via this method. Eligible Entrant should check their phone capabilities for specific text messaging instructions. Text messaging is not available in all areas.

2) Online Entry Form: Visit [nyjets.com/opener](https://nyjets.com/opener) during the Promotion Period and follow the instructions provided to complete/submit the Official Entry Form to receive one (1) entry.

**All entries must be received by 11:59:59 pm ET on 9/8/24 to be eligible. Limit one (1) entry per person, per email address and per household throughout the Promotion Period. You may only use one (1) email address to enter the Sweepstakes. Entries received from any person, email address, or household in excess of the above stated limitation will be void.** Your submission of an entry constitutes your consent to participate in this Sweepstakes and your consent for Sponsor to obtain, use and transfer your name, email address, address and other information for the purpose of administering this Sweepstakes. The use of script, macro or automated devices (or any other devices intended to automate or subvert any aspect of entry) to enter the Sweepstakes is prohibited and any entry through such means and any entry that is deemed to be ineligible (at Sponsor's sole discretion and in accordance with these Official Rules) will be void. Winner and his/her respective guest(s) will be escorted out of venue by Sponsor or its designated agent(s) for improper conduct and/or violation of federal, state or local laws (including, but not limited to, the unlawful possession, use, or distribution of illicit drugs, unlawful drug paraphernalia, and alcohol), as Sponsor determines in its sole discretion, and will forfeit the balance of prize.
