## NY Jets Back In Black Sweepstakes Official Rules NO PURCHASE OR TEXT MESSAGE NECESSARY TO ENTER OR WIN.

- 1) Eligibility: The NY Jets Back In Black Sweepstakes (hereafter, "Sweepstakes") is open to legal permanent residents of the 50 United States (and the District of Columbia) who are at least eighteen (18) years of age at the time of entry (hereafter, "Eligible Entrants").   - 3) Online Entry Form: To receive one (1) entry without opting-in to receive text messages,

Eligible Entrants can visit nyjets.com/backinblack during the Promotion Period and follow the instructions provided to complete/submit the Official Entry Form to receive one (1) entry.

There will be a limit of one (1) entry per person, regardless of the method of entry. Entries received in excess of the stated limitation will be void. All entries become the exclusive property of the Sponsor and will not be acknowledged or returned.
