

NY Jets Ticket Sell-Back Credit Program – Exclusive Multi-Seat Season Ticket Holder Benefit!

For the 2025-26 season, the NY Jets will again offer multi-seat season ticket holders the flexibility to exchange tickets and parking passes for games they cannot attend for a credit toward the 2026-27 season through the Ticket Sell-Back Credit Program ("Credit Program")!

Here are the terms for the NY Jets Ticket Sell-Back Credit Program:

- I. Up to three (3) regular season home games of the current (2025 -26) season can be included in the Credit Program, per season ticket account. Preseason and post-season game(s) are not eligible.
- II. The Credit Program will run from June 18, 2025 to August 27, 2025 (the "Credit Window"). For any eligible games turned back in during the Credit Window, a credit will be applied to the individual season ticket holder's account, which will be applied towards their 2026-27 season ticket renewal fee (the "Credit"). The amount of the Credit for each ticket or parking pass will correspond to the amount paid for that ticket or parking pass as reflected on the account holder's season ticket invoice for the 2025-26 NFL season. Within the Credit Window, the following deadlines will apply to tickets for each eligible game:
 - a. The deadline to sell-back tickets and parking for the 9.7, 9.14, 10.5 and 10.19 home games is July 31, 2025.
 - b. The deadline to sell-back tickets and parking for the 11.9, 11.30, 12.7 and 12.28 home games is August 27, 2025.
- III. The Credit Program process will occur fully online. Ticket Credits will only be available through Jets Account Manager (it will not be available on the Jets' mobile app). Further instruction will be communicated prior to the commencement of the ticket Credit Window.
- IV. Any tickets and parking passes returned to the Jets through the Credit Program cannot later be sold back to the season ticket member.
- V. The Credit MUST be used only for subsequent 2026 -27 NFL season ticket renewals and cannot be transferred or used for any other purchases. This is a ticket and parking pass credit only and does not entitle the season ticket holder to a cash refund. Furthermore, the Credit cannot be rolled over for any future seasons or for any purpose other than paying for the 2026-27 season ticket renewal. If you do not renew for the 2026-27 NFL season, the Credit will expire and not be made available for future seasons.
- VI. Seats must be adjacent to be eligible for the Credit Program. Partial ticket exchanges will be considered under certain conditions (i.e., exchanging only two (2) of four (4) seats), however, a partial ticket exchange will still count as 1 of the 3 games eligible to be exchanged for Credit. Single seat credits are not eligible; this offer is only available for 2 or more adjacent tickets.
- VII. Accounts are not able to move or change their season ticket locations for the 2025-26 season once seats are returned through the Credit Program.
- VIII. For season ticket holders to be eligible for the Credit Program, the following terms apply:
 - a. Only multi-seat accounts are eligible.
 - b. Accounts must be paid in full and/or the selected game(s) must be fully paid to participate.

- c. Any tickets or parking passes that have been transferred, posted for re-sale, or donated to a third-party are not eligible for the Credit Program.

Each game credit value will follow the variable ticket pricing schedule.
